Regular Meeting - May 5, 1999

A Regular Meeting of the San Clemente City Council was called to order on May 5, 1999 at 7:00 p.m. in the Council Chambers, located at 100 Avenida Presidio, San Clemente, California.

Rev. Steve Petty, St. Andrew's by the Sea United Methodist Church, gave the invocation.

PLEDGE OF ALLEGIANCE

Councilmember Eggleston led the Pledge of Allegiance.

1. SPECIAL PRESENTATIONS

A. <u>Certificate of Recognition - San Clemente High School Cheerleaders</u> and Coaches

Mayor Berg presented Certificates of Recognition to members of the San Clemente High School cheerleading squad, as well as coaches Melinda Forest and Ingrid Dahl and Judy Bailey, Advisor, winners of the Varsity Division at the Disneyland West Coast Championships.

B. Veterans Appreciation Month Proclamation

Mayor Berg presented a proclamation to Joseph Deas declaring the month of May as Veterans Appreciation Month.

C. Senior Center Awareness Week Proclamation

Mayor Berg presented a proclamation to Cathy Lee, Director of the San Clemente Seaside Center, declaring May 9-15, 1999 as Senior Center Awareness Week.

2. MOTION BY COUNCILMEMBER DIEHL, SECOND BY COUNCILMEMBER DAHL, CARRIED 5-0, to waive reading in full of all Resolutions and Ordinances.

3. **PUBLIC HEARINGS**

A. Local Coastal Program Certification

Public Hearing to consider amending the Coastal Implementation Plan to incorporate the California Coastal Commission suggested modifications to certify the City of San Clemente Local Coastal Program.

Community Development Director Holloway explained that a memorandum from Staff, dated May 4, 1999, has been placed on the dais that addresses a letter received from Bill Hart, of DeRail the Trail, concerning the Local Coastal Plan; requested that Council decide whether to consider the Local Coastal Program Certification this evening or continue the issue in light of the recent arrival of DeRail the Trail's recommended modification.

Mayor Berg opened the Public Hearing.

Bill Hart, DeRail the Trail, voiced concern that one section of the Local Coastal Plan is inconsistent with the Coastal Commission's enforcement effort to require OCTA to obtain a Coastal Development Permit for work that legally requires a CDP; stated he drafted a modification to Section 17.20.50(5), Roadway/Transportation Maintenance, of the City's Implementation Plan which has been refined by Staff; recommended that Council proceed with the Local Coastal Program Certification this evening.

Associate Planner Pechous provided a general overview of the Local Coastal Program Certification, which would transfer permit authority over the Coastal Zone in San Clemente to the City; summarized the recommended modification to Section 17.20.50(5), Roadway/Transportation Maintenance, of the City's Implementation Plan; stated that Staff is recommending that Section 17.20.50(5) be modified to read as follows:

"The ongoing repair or maintenance activities of the City, state agencies, and public utilities (such as railroads) involving shoreline works protecting transportation roadways are exempt from Coastal Development Permit review unless activity involves work on the beach, or in an ESHA, or the activity has been determined by the Coastal Commission to require a Coastal Development Permit in order to mitigate any adverse impacts on coastal resources, including scenic resources. Activities in this category that are exempt from the requirement to obtain a Coastal Development Permit are The provisions of this section shall not be applicable to those activities specifically described in the "Repair, Maintenance and Utility Hook-Ups" document, adopted by the California Coastal Commission September 5, 1998."

Note: The above verbiage varies from the Staff Recommendation contained in the memorandum dated May 4, 1999 and reflects Staff's most-recent recommendation.

Associate Planner Pechous noted that the Coastal Commission hearing will not take place until August 1999 and hence a continuance of the matter this evening will not negatively affect the process.

MOTION BY COUNCILMEMBER DIEHL, SECOND BY COUNCILMEMBER EGGLESTON, CARRIED 5-0, to continue the Public Hearing on the Local Coastal Program Certification to the Council Meeting of May 19, 1999.

B. <u>Discretionary Sign Permit (DSP) 99-22 and Amendment to Sign Exception (AM SE) 90-28 – Unocal 76</u>

Public Hearing to consider a request for approval of a discretionary sign permit, and an amendment to the conditions of approval for a previously approved sign exception permit, to allow the replacement of an existing sandblasted wood sign with an internally illuminated monument sign for the gas station located at 1201 South El Camino Real.

Associate Planner Martin reviewed the contents of the Administrative Report.

Council acknowledged the advent of new technology that enables concrete to resemble wood; noted the possibility of approving the application with the understanding that state-of-the-art technology can be utilized to improve the longevity of the sign material.

Mayor Berg opened the Public Hearing.

Eddie Vidales, Donco and Sons (Sign Contractor), explained that the proposal involves a sign that includes a wood element; commented that the wood sign that presently exists will not last long because of the salty air; estimated that signs similar to the type being proposed will last approximately 10 years in a coastal environment.

There being no others desiring to speak to this issue, the Public Hearing was closed.

MOTION BY COUNCILMEMBER DIEHL, SECOND BY COUNCILMEMBER EGGLESTON, CARRIED 5-0, to adopt Resolution No. 99-31 entitled A RESOLUTION OF THE CITY COUNCIL OF SAN CLEMENTE, CALIFORNIA, APPROVING DISCRETIONARY SIGN PERMIT (DSP) 99-22 AND AN AMENDMENT TO PREVIOUSLY APPROVED SIGN EXCEPTION (SE) 90-28, TO INSTALL A REPLACEMENT MONUMENT SIGN ON THE EXISTING GAS STATION SITE LOCATION AT 1201 SOUTH EL CAMINO REAL.

Council acknowledged that major sign changes, especially sign exceptions, should be considered by Council. Council requested, however, that Staff consider means of allowing existing signs to be replaced with state-of-the-art materials (provided the configuration and appearance of the sign remains the same) at the Staff level.

C. Weed Abatement 1999 - Order to Abate

Public Hearing to consider protests or objections to the abatement of weeds, rubbish, refuse and dirt upon streets, sidewalks, parkways and private property within the City of San Clemente.

Beaches and Parks Manager Reed reviewed the contents of the Administrative Report.

Mayor Berg opened the Public Hearing.

Robert A. Kegel, San Clemente, stated he owns a 60' x 90' lot in San Clemente; commented that he addressed Council in 1997 to voice his concern that the City charged him an excessive rate to clear his lot (i.e., \$400, which included \$170 in administrative fees); stated that he hired a private company to remove weeds from his property in 1998 for a cost of \$125; voiced concern that the City cleared the lot again in August (without permission to trespass), for which he received a bill for \$293.33, which included \$170.83 for administrative costs and \$122.50 for lot clearing; voiced concern that Mr. Oatis, the City's contractor, never informed him that there was a problem with his lot; opined that the situation does not constitute a public nuisance and that the City's standards are vague.

City Attorney Oderman clarified that the City is not required to obtain a warrant to access property to remove weeds; explained that weed abatement is a recognized exception to the warrant requirement inasmuch as it is an open area and involves a public safety issue (i.e., fire hazard); disagreed that the City's standards are vague, noting that weeds are required to be cut to I" in height.

Beaches and Parks Manager Reed explained that administrative costs are established by dividing the cost to administer the weed abatement program by the number of lots that are cleared; commented that a second weed abatement program was undertaken in 1998; stressed that property owners are required to keep their lots clear of weeds throughout the year; stated that he does not know whether the weeds were cleared on Mr. Kegel's property because of secondary growth or because the contractor failed to cut the weeds to City standards.

Council requested that Beaches and Parks Manager Reed investigate the circumstances concerning Mr. Kegel's billing.

Council noted that Mr. Kegel's concerns relate to the 1998 weed abatement program and that the issue currently before Council relates to the 1999 weed abatement program.

There being no others desiring to speak to this issue, the Public Hearing was closed.

Nida Brown, San Clemente, stated she resides on Calle de los Alamos and is anxious about the proposed assessment; questioned and received clarification that a Public Meeting on the issue will be held on June 17, 1999, and a Public Hearing will be held on July 7, 1999; requested to be mailed a copy of the assessment.

Bill Hart, resident of Calle de los Alamos, urged that Council authorize the ballot procedure to commence so that residents can voice their preferences.

Jim Grace, San Clemente, stated that this is the third time an Assessment District has been considered for the subject area, noting that the first time it was proposed, the cost would have been \$3,000 per property, but is now \$17,000 per property; expressed hope that the District will come to fruition at this time.

Wayne McMurray, San Clemente, opined that this is the time to underground the utilities; suggested that property values will be enhanced above the cost of the undergrounding.

Classic Auto Show - Request for Presentation of Mayor's Trophy

Ron Runolfson and Dave Anderson explained that the Downtown Business Association is promoting the Classic Auto Show that will take place this year on June 13, 1999; requested that Council begin a tradition of presenting a Mayor's Trophy to its favorite car.

Parking Citation - Metrolink Station

Mary Tranckino, San Clemente, stated that she, along with two other people, inserted dollars into the parking machine at the Metrolink Station, but failed to receive a receipt; voiced concern that she subsequently received a \$35 citation, even though she had inserted money into the machine; requested that the City rescind the citation and implement measures to prevent this situation from happening in the future.

Staff responded that the machine keeps a record of transactions regardless of whether a receipt is produced; agreed to verify the accuracy of Ms. Tranckino's statement and to void the citation if payment was made; noted that people may purchase annual parking passes.

Mayor Pro Tem Ritschel reported that a working group meeting took place two weeks ago with regard to the Equity Study; noted a second meeting is scheduled for May 14, 1999 and, if needed, an additional meeting will be held in June; stated that the working group is attempting to consolidate comments from the various cities for presentation to the OCFA Board in June or July.

Councilmember Dahl reported on animals available for adoption at the San Clemente Animal Shelter; expressed appreciation to the CASA volunteers.

(5) Transportation Corridor Agencies Status Report

Councilmember Dahl reported that a TCA walk-in service center will open in the 200 block of Avenida Del Mar on June 1, 1999; stated the mitigation efforts for San Onofre State Park have received Board approval and a \$70,000 study will be conducted on the San Mateo Campground; explained that the EIS is projected to be completed, and the Public Hearing process before the TCA is expected to commence, in early 2000.

1999 Cinco de Mayo Fiesta

Councilmember Diehl reported on the success of the Cinco de Mayo Fiesta which was held on Saturday, May 1, 1999 at Max Berg Plaza Park.

<u>Fundraiser at The Heritage – George Zeleski Autographed</u> <u>Cartoons</u>

Councilmember Eggleston stated that a fundraiser was held on May 1, 1999 at the Heritage Foundation to help fund new uniforms for the San Clemente High School band; noted that \$750 was raised from the sale of cartoons autographed by George Zeleski.

The Heritage – New Exhibits

Councilmember Eggleston stated that two new exhibits will open on May 15, 1999 at 1:00 p.m. at The Heritage, i.e., Pat Nixon, the First Lady and a 4' x 6' model of the Western White House.

Mayor Berg suggested the possibility of adopting a guideline whereby Council will not introduce any new agenda items after 11:00 p.m. -- unless a vote is passed to proceed with the consideration of a new item.

City Manager Parness noted that Staff will submit a report to Council for the May 19, 1999 Council Meeting relating to possible means of streamlining Council meetings.

Beach Ad Hoc Committee

Mayor Pro Tem Ritschel reported that the Beach Ad Hoc Committee conducted its beach walk from North Beach to Riviera last Friday, noting that the remaining beach areas in the City will be toured at a later date; stated the next Committee meeting will take place on May 12, 1999.
