RESOLUTION NO. 24-21

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, OPPOSING ASSEMBLY CONSTITUTIONAL AMENDMENT 1

WHEREAS, in 1978, California voters amended the California Constitution by passing the landmark Proposition 13 ("Proposition 13"), an initiative prohibiting the ad valorem tax rate on real property from exceeding one percent (1%) of the full cash value of the property, subject to certain exceptions; and

WHEREAS, Proposition 13 greatly protects taxpayers and their families by additionally prohibiting any city, county, or special district from imposing a special tax unless imposed by a two thirds (2/3) supermajority vote of the voters in that jurisdiction, subject to certain exceptions; and

WHEREAS, proposed Assembly Constitutional Amendment 1 ("ACA 1") would amend the California Constitution to create additional, dangerous-to-taxpayers, exceptions to Proposition 13 by lowering the two- thirds (66%) supermajority voter threshold to only fifty-five percent (55%) for local jurisdictions to levy an ad valorem tax on real property to pay for bonds issued by the local jurisdiction to fund public infrastructure, affordable housing, down payment assistance, and permanent supportive housing for persons at risk of chronic homelessness, or the acquisition or lease of real property for such purposes; and

WHEREAS, the constant attempts by the State Legislature to erode the important taxpayer protections of Proposition 13 results in overall higher taxes and increases the already onerous tax burden on ALL Californians, and runs counter to conserving economic opportunity in California; and

WHEREAS, the City Council of San Clemente, CA strongly opposes ACA 1 due to the horrible exceptions it would create to the taxpayer protections enshrined in the California Constitution by Proposition 13, and encourages voters to vote a resounding NO on ACA1; now, therefore be it

NOW, THEREFORE, The City Council of the City of San Clemente does hereby resolve as follows:

Section 1. The City Council of San Clemente, CA hereby recommits its staunch support of Taxpayer Rights afforded by Proposition 13, while staunchly opposing the destructive, money-grab attempts of ACA1.
