## 1. BUDGET\_REVIEW SESSION

City Manager Hendrickson provided an overview of the proposed City budget for FY 1988-89; advised staff is recommending that no full-time positions be added; noted the budget contains recommendations to 1) decrease sewer charges by 10% and increase water service charges by 9%; summarized the priority areas Council identified during the mid-year budget review process; outlined total budget expenditures as compared to the 1987-88 budget; advised that a \$250,000 contingency reserve is included in the budget, but voiced concern that the figure does not represent a prudent reserve; stated no funds have been budgeted to defend the City, if sued by developers, in the event the Citizens' Sensible Growth and Traffic Control Initiative is passed on June 7, 1988; underscored the importance of economic development.

Assistant City Manager Hulsizer explained the rationale of Project REACH and noted that each City department will utilize Project REACH criteria to elevate their level of service.

Public Works Director Sorg reviewed the proposed budget for the Public Services Department.

Bob Boyer, Human Resources Ad Hoc Committee, urged Council to allocate funds to enable the Human Resources Committee to respond to human needs in the community.
