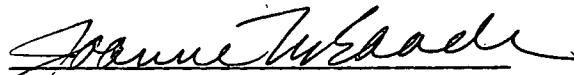

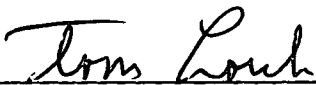

ELECTION OF MAYOR AND MAYOR PRO TEM

Mayor Veale expressed appreciation to Council for their help and support during her mayoral term.

Council complimented and thanked Mayor Veale for her exceptional leadership and dedication.

Election of Mayor

City Clerk Erway opened nominations for the office of Mayor. Councilmember Rice nominated Councilmember Lorch. MOTION BY COUNCILMEMBER VEALE, SECOND BY COUNCILMEMBER RICE, CARRIED 4-1 (COUNCILMEMBER LIMBERG VOTING NOE), to close the nominations. Councilmember Lorch was elected Mayor by a 3-2 vote (Councilmembers Limberg and Mecham voting noe.)

Mayor Lorch expressed appreciation to the Council; advised Council and staff will continue to work diligently for the benefit of the City.

Election of Mayor Pro Tem

Mayor Lorch opened nominations for the office of Mayor Pro Tem. Councilmember Limberg nominated Councilmember Rice. MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 5-0, to close the nominations. Councilmember Rice was elected Mayor Pro Tem by a 5-0 vote.

2. MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER MECHAM, CARRIED 5-0, to waive reading in full of all Resolutions and Ordinances.

3. PUBLIC HEARINGS

- A. Fireworks - Public Sale and Use Within City of San Clemente

Public Hearing to consider banning the public sale and use of fireworks within the City of San Clemente.

Fire Protection Director Dailey reviewed the contents of the Administrative Report; voiced concern that San Clemente is currently the only area in South Orange County where fireworks are permitted; advised fireworks are prohibited in San Diego County.

Mayor Lorch opened the Public Hearing.

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER VEALE to introduce Ordinance No. 956 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA AMENDING SECTION 20-3 (q) OF THE CODE OF THE CITY OF SAN CLEMENTE PERTAINING TO FIREWORKS.

SUBSTITUTE MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER RICE, to place on the ballot of the next regular election the question of whether or not the use and sale of fireworks within the City should be banned.

MOTION BY COUNCILMEMBER VEALE, SECOND BY COUNCILMEMBER MECHAM, to amend the Substitute Motion to direct the City Attorney to prepare an Ordinance which would prohibit fireworks pending the results of the city election. Following discussion, Councilmembers Veale and Mecham withdrew their motion.

SUBSTITUTE MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER MECHAM, CARRIED 5-0, to 1) place on the November, 1988 ballot the question of whether or not the use and sale of fireworks should be banned within the City; and 2) direct the City Attorney to prepare an Ordinance which would prohibit fireworks pending the results of the November, 1988 election.

B. Use Permit 87-22 - Sea Coast Estates.

Public Hearing to consider an appeal of the Planning Commission decision to allow a temporary sales trailer for Sea Coast Estates, located at 2927 Calle Gaucho.

Barry Richards, Appellant, 619 Calle Reata, relayed his belief that the corner of Calle Guadalajara and Calle Gaucho is an inappropriate location for the sales trailer; stated Calle Guadalajara is a main thoroughfare with a steep grade at the proposed trailer site; felt that situating the sales trailer at the proposed location would increase the accident potential; presented a letter from Lee H. Durst (attorney representing The Coast Homeowners Association) to J. P. Rhoades Development, dated November 4, 1987, which demanded submission of development plans to The Coast Homeowners Association.

Jeffrey Rhoades, Applicant, President of J. P. Rhoades Development, stated the development plans were submitted to The Coast Homeowners Association two weeks ago; stated their insurance carrier is opposed to situating the sales trailer adjacent to models under construction. In response to a question posed by the City Attorney, Mr. Rhoades acknowledged that Rhoades Development is required to submit all plans to the Architectural Review Committee and to obtain their approval.

Ron Mehrens, 2924 Calle Guadalajara, spoke in opposition to the proposed location of the sales trailer; suggested the trailer be located near the western portion of the development.

Robert Sheridan, 2926 Calle Guadalajara, opposed locating the sales trailer at the proposed location, noting that Calle Guadalajara is heavily traveled.

Don Duffey, 2922 Calle Guadalajara, urged Council to deny the request to situate the sales trailer at the proposed location.

There being no others desiring to speak to this issue, the Public Hearing was closed.

MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER VEALE to adopt Resolution No. 87-86 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING USE PERMIT 87-22.

COUNCILMEMBER MECHAM to approve Use Permit 87-22, but to require the sales trailer to be relocated to Calle Via Chueca.

City Attorney Oderman opined that relocation of the sales trailer would need to be re-noticed and considered by the Planning Commission.

SUBSTITUTE MOTION BY COUNCILMEMBER RICE, SECOND BY COUNCILMEMBER MECHAM, FAILED 2-3 (COUNCILMEMBERS LIMBERG, MECHAM AND VEALE VOTING NOE), to refer Use Permit 87-22 back to staff and the Planning Commission for re-noticing and consideration of relocating the sales trailer to Calle Via Chueca.

AMENDED MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER VEALE, CARRIED 3-2 (MAYOR LORCH AND COUNCILMEMBER RICE VOTING NOE), to adopt Resolution No. 87-86 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING USE PERMIT 87-22; with the understanding that an additional condition will be added to provide that the sales trailer be removed within 30 days of the issuance of Certificates of Occupancy for the model homes.

C. Use Permit 87-21 - Germick and Edmonds Development

Public Hearing to consider approving a 15,500 square foot, 34 foot high office and retail building, located at 1400 N. El Camino Real.

Mayor Lorch opened the Public Hearing.

Tom Coffin, Project Architect, 210 San Antonio, reviewed the architecture of the development.

Frank Germick, 230 Avenida Vista Del Oceano, opined the development would be one of the finest in San Clemente; stated the Community Design Commission unanimously approved the development; stated 43% of the frontage of the building is open because of the courtyard.

Wes Landen, 613 Calle del Cerrito, on behalf of the Community Design Commission, spoke in support of the project; urged Council approval as proposed.

Stephen Scibelli, 612 Avenida Acapulco, stated the project is pleasing and unique; urged Council approval of the project as submitted.

Ed Kweskin, 118 W. Avenida Valencia, representing the Planning Commission, stated the proposal is consistent with the City; felt the project executes desired architecture.

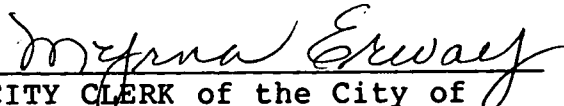

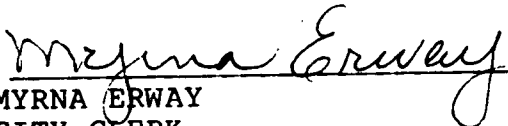
