An Adjourned Regular Meeting of the City Council of the City of San Clemente, conducted in the Council Chambers, Civic Center Building, 100 Avenida Presidio, was called to order by Mayor Veale at 7:15 p.m.

ALSO PRESENT James B. Hendrickson, City Manager; Greg Hulsizer, Assistant City Manager; Dean Porter, Finance Director; Jim Holloway, Community Development Director; Bill Cameron, City Engineer; Myrna Erway, City Clerk; and certain other staff members present in the audience.

REDEVELOPMENT AGENCY

Milt Farrell, Executive Director of the California Redevelopment Association, gave a video presentation reviewing the redevelopment process and responded to questions from Council.

Community Development Director Holloway reviewed the background papers provided in the agenda packet, focusing on the proposed area enhancement program and the Pier Bowl rehabilitation program; reviewed the proposed use of funding for RDA projects.

Councilmember Lorch requested that staff prepare a map of the City delineating current and potential RDA areas; voiced concern that no funding is slated for City Hall for this fiscal year.

Peter Rock, 4421 South El Camino Real, spoke in support of the attainment of low-interest loans for RDA projects.

Rick Anderson, 610 Avenida Victoria, spoke on the need for enhancement of the Pier Bowl area, suggesting that a parking

structure be considered.

Ed Kweskin, 118 W. Avenida Valencia, indicated support for the redevelopment of the Pier Bowl and North Beach areas.

Steve Kingston, 4011 Calle Abril, cited the need for additional code enforcement in the City.

Mayor Veale expressed a desire for a master plan and improved parking; recommended taking full advantage of the RDA program.


An adjourned regular meeting of the San Clemente City Council was held in the Council Chambers on May 26, 1987 and was called to order at 7:00 p.m.
