A Regular Meeting of the City Council of the City of San Clemente, conducted in the Council Chambers, Civic Center Building, 100 Avenida Presidio, was called to order by Mayor Veale at 7:00 p.m.

INVOCATION

Pastor Alan Morse, of Victory Baptist Church, gave the invocation.

PLEDGE OF ALLEGIANCE

Mayor Veale led the Pledge of Allegiance.

1. SPECIAL PRESENTATIONS

- A. Mayor Veale introduced and presented City pins to Principal Jim Henderson, Vice Principal Doug Price, ASB Advisory Dori Szpisjak and the following members of the Shorecliffs Junior High Student Council: Kendra Larsen, Dominique Chehock, Shashona Padilla, Jennifer Chu, Aimee Perkoski, Patti Castillo, April Hawkins, Trena Mason, Erin McCaskill, and Erica Matson.

- B. Recognition of the Soroptimist Scholarship recipients was deferred to the Council meeting of June 17, 1987.
2. MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 5-0, to waive reading in full of all Resolutions and Ordinances.
3. PUBLIC HEARINGS

A. Nuisance Abatement of Trash, Debris and Abandoned Vehicles - Forster Ranch Development

Report from the Community Development Director concerning an alleged public nuisance in the Forster Ranch Development and Planning Area.

Community Development Director Holloway advised that staff conducted an on-site inspection and became aware that some remedial work has taken place in the Forster Ranch area; recommended, however, that Council still declare certain areas in the Forster Ranch development and planning area to be a public nuisance and order abatement of such, inasmuch as some items listed in the Administrative Report are still not completed.

Mayor Veale opened the Public Hearing and there being no one desiring to speak to this issue, the Public Hearing was closed.

Council requested follow-up by staff to ensure no further dumping of trash at the end of Los Mares.

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 5-0, to adopt Resolution No. 87-51, entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, DECLARING CERTAIN AREAS IN THE FORSTER RANCH DEVELOPMENT AND PLANNING AREA TO BE A PUBLIC NUISANCE AND ORDERING ABATEMENT OF SUCH.

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 5-0, to authorize the City Manager to solicit bids and award to the lowest responsible bidder so the abatement can be undertaken on a timely basis, in the case that this work is not undertaken by Estrella Properties, within 30 days of passage of the resolution.

B. FY 1987-88 Street Lighting and Landscaping District No. 1

Report from the Community Development Director concerning confirmation of the diagram and the assessment for fiscal year 1987-88 Lighting and Landscaping District No. 1, and providing for annual assessment levy as set forth in the Engineer's Report.

City Manager Hendrickson advised the assessment would raise approximately \$25,000; commented the Street Lighting and Landscaping District will be reviewed by Council at its budget meeting on June 9, 1987; stated the Council and Parks and Recreation Commission have indicated a desire to include additional capital improvements; recommended the Public Hearing on this item be continued to the City Council meeting of June 17, 1987.

Mayor Veale opened the Public Hearing.

Mark Carr, 719 Calle Casita, stated the Street Lighting and Landscaping District has been operating at a deficit for several years; voiced concern that the proposed budget for FY 1987/88 projects a deficit of \$56,470; stated it is necessary to find a means to increase revenue.

Karoline Koester, 401 Via Pajaro, voiced concern with the proposed continuance of this item; requested that staff question the Assessment Engineer as to why all expenditures weren't subtracted from all revenues for each year, rather than holding a reserve over to the following year.

Staff clarified that the Street Lighting and Landscaping District is not in a deficit situation, although the annual expenditures do exceed the annual revenues.

During the course of discussion, Council requested that staff respond to the following at the June 17, 1987 Public Hearing on this item:

1. Why expenditures weren't subtracted from revenues for each year, as opposed to holding over a reserve to the following year.
2. Feasibility of the request of the Ocean Hills Homeowners Association to reappropriate the \$30,000 previously appropriated for the improvement of the Los Mares median, as contained in their letter,

dated May 27, 1987, and on file in the City Clerk's Office.

3. Methodology utilized to determine assessments.
4. Whether State Code requires an accounting procedure that ends with a zero balance.

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 5-0, to continue the Public Hearing on the FY 1987-88 Street Lighting and Landscaping District No. 1 to the City Council meeting of June 17, 1987.

C. FY 1987-88 Budget

Mayor Veale opened the Public Hearing.

Carol Stone, Executive Director of the Volunteer Center of South Orange County, 28052 Camino Capistrano #214, Laguna Niguel, reviewed that the function of the Center is to recruit and place volunteers in non-profit organizations; proposed a volunteer program for the City of San Clemente.

Bernie Kautz, representing the Volunteer Center of South Orange County, summarized the success of the Los Angeles City Volunteer Program; urged that Council budget a full-time (or part-time as an alternate) Volunteer Coordinator to be hired by the Center, but to work for the City.

R. B. Cropley, 210 Esplanade, addressed the need for a beach cleaner, increased maintenance of T-Street Beach, and a bulldozer to keep the beach level. City Manager Hendrickson advised that a beach cleaner has been included in the proposed FY 1987/88 budget.

Representatives of the Volunteer Center of South Orange County were questioned and confirmed that the organization does court referrals to clean up trash in parks and along the freeway.

Mayor Veale closed the Public Hearing, there being no others desiring to speak to this issue.

The next Council meeting on the FY 1987/88 budget (Police and Public Services Departments) will be held Tuesday, June 9, 1987 at 7:00 p.m. It is anticipated that Council will adopt the budget at its meeting of June 17, 1987.

D. Encroachment 87-01 (Harbor House Cafe - 2016 S. El Camino Real

Report from the Community Development Director concerning a request to allow a planter retaining wall to encroach 5' into the public right-of-way.

City Planner Barnes summarized the contents of the Administrative Report; stated that no adverse effects are anticipated as a result of the proposed encroachment into the City's right-of-way; noted the street is presently improved to its full width.

Mayor Veale opened the Public Hearing and there being no one desiring to speak to this issue, the Public Hearing was closed.

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LORCH, to adopt Resolution No. 87-50 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING ENCROACHMENT PERMIT NO. 87-01, with additional Conditions as follows:

1. That applicant enter into an agreement which indicates that insurance coverage for the property covers the area of the encroachment.
2. In the event of any injuries, damages or losses in the encroachment area, the property owner will indemnify and hold the City harmless from any liability.
3. The encroachment will not be effective unless applicant gives his consent within 30 days of Council action.

During the course of discussion, Council voiced concerns as follows: 1) the proposed planter retaining wall encroachment was not included in the initial design for the Harbor House and hence never reviewed by the Community Design Commission; 2) whether the encroachment is justified; 3) merits of granting a revocable encroachment permit; and 4) the lighting situation associated with the restaurant.

SUBSTITUTE MOTION BY COUNCILMEMBER MECHAM to continue the Public Hearing on Encroachment 87-01. The motion died for lack of a second.

Following additional discussion, SUBSTITUTE MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 4-1 (COUNCILMEMBER LORCH VOTING NOE), to re-

open the Public Hearing and continue consideration of Encroachment 87-01 to the City Council meeting of July 1, 1987 to enable staff and the applicant to respond to the concerns raised by Council.

C. Private Fireworks Display - June 13, 1987

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 5-0, to authorize the Director of Fire Protection to issue a fireworks display permit, private type, to enable Allergan Pharmaceutical Company to conduct a private fireworks display on June 13, 1987, subject to the customary \$400 charge plus the costs of the engine company and the Fire Prevention Bureau Inspector to stand by during the display.

E. SB1037 (Torres) - Cancer Presumption for Firefighters

2. Authorize the Mayor to submit letters of opposition to SB1037 (Torres) to members of the Appropriations Committee and other State officials.

B. Revision of Uniform Plumbing Code

Report from Community Development Director concerning deletion of Section 27-2(1) of the City Code so that copper tube used for water piping in structures will meet the UPC minimum requirements.

C. Professional Surfing Association of America Surf Contest

Report from Director of Public Services and Acting Police Chief concerning a request by the Professional Surfing Association of America to hold a surf contest north of the pier.

MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER MECHAM, CARRIED 5-0, to approve the PSAA contest to be held July 23-26, 1987, subject to the conditions specifically set forth in the Administrative Report, dated May 27, 1987, and on file in the City Clerk's Office.

8. ORAL COMMUNICATIONS

Sharron Gill, 2211 Via Gavilan, spoke in support of former Police Chief Kelson McDaniel, stating that he is highly rated among Police Chiefs and officers in the County; felt a proper hearing should be conducted.

Daniel Phillips, 216 La Cuesta, felt a hearing should be held to enable Kelson McDaniel to respond to the accusations made against him and to clear his name and reputation.

Maurice Hansen, 175 Avenida Alessandro, relayed his belief that Kelson McDaniel was denied due process; urged Council to reconsider the situation.

Harry Hanes, 606 Calle Bienvenido, opined that an injustice has taken place with respect to the Police Chief situation; felt Kelson McDaniel should be provided an opportunity to respond; stated that he represents the opinion of approximately 100 people.

W. E. Slack, 209 West Paseo de Cristobal, presented and read a letter, on file in the City Clerk's Office, which indicated his belief that Kelson McDaniel was denied due process.

Joseph Barton, 620 Calle Vicinte, stated he worked for the Los Angeles Police Department for 25 years and the practices that Kelson McDaniel brought to the City were in practice in Los Angeles for 20 years; urged that Kelson McDaniel be given the opportunity to defend himself.

Nancy Mason, 355 Calle Burro, stated she felt secure when Kelson McDaniel was the Police Chief.

Jim Green, 315-C Santa Barbara, felt that a Review Committee should be established to hear officer and citizen complaints about police matters.

Ed May, 121 Boca De La Playa, voiced concern that police officers not be permitted to dictate the operations of the Police Department.

Candice Flock, 233-A West Miramar, stated she is disappointed that Kelson McDaniel has not been given a fair trial.

Council stated the City is continuing to address the situation; expressed confidence in Acting Police Chief Ehlow; advised that personnel matters are, as allowed by
