## JOINT CITY COUNCIL/PLANNING COMMISSION MEETING

## ADJOURNED MEETING - JUNE 17, 1987

An Adjourned Joint Meeting of the City Council and Planning Commission was called to order by Mayor Veale at 5:40 p.m. in the Mayor's Conference Room, Civic Center Building, 100 Avenida Presidio, San Clemente.

## 1. ROLL CALL

Planning Commission Chairman Kweskin reviewed the June 16, 1987 Planning Commission meeting which included the Marble-head Coastal Specific Plan and EIR; relayed that the EIR Consultant has estimated that the Vista Hermosa interchange will not occur for six years; noted the Planning Commission concurred with staff re the deficiency of open space; stated Commissioner Joseph, Community Development Director Holloway, and he will meet with the applicant in an effort to resolve outstanding issues.

Councilmember Mecham noted that the 30% open space requirement isn't consistent with the inner city.

Councilmember Limberg felt the primary issue to be the density of development; noted the project has a higher commercial concentration than prior to Proposition B; stated Council previously discussed credits for commercial development (15% commercial in residential areas); felt Rancho San Clemente is too dense; recommended studying and considering the calculations previously discussed and evaluating the character of the project to ensure suitability for the City.

Councilmember Rice expressed his disagreement with the proposed car center.

Councilmember Lorch spoke in support of 1) a larger park area; 2) situating the higher density uses closer to Avenida Pico; and 3) saving some of the canyon and keeping the canyon more natural.

During the course of discussion, it was suggested that perhaps the entry on Vista Hermosa could be constructed in a fashion similar to the Village of Turtlerock in Irvine, with the canyon area being left in its current state.

Planning Commissioner Neville reviewed the Civic Center site; reiterated the criteria for selecting the Marblehead Coastal site by the Blue Ribbon Committee; recommended another review and adherence to the established criteria.

Councilmember Limberg expressed his preference for a multipurpose civic center with a park-like setting adjacent to the library; commented on the possibility of establishing a community cultural center (containing auditorium and meeting rooms) which would be the focal point of the City.

Planning Commissioner Joseph concurred with Councilmember Limberg and recommended a re-review of the Blue Ribbon Committee Report.

Councilmember Rice indicated non-support of the Civic Center site.

Planning Commission Chairman Kweskin advised that the Specific Plan contains two phases; the first phase being the land use plan and the second phase dealing with specific uses.

Planning Commission Chairman Kweskin reviewed his memorandum addressed to the City Council and Planning Commission entitled "Processing of Applications for Development and Construction: A Crisis", which is on file in the City Clerk's Department.

Community Design Commissioners Landen, Mertens and Nicol addressed the need for discretionary review and improved guidelines; noted the City of San Juan Capistrano has a viable Community Design Commission.

Community Design Commissioner Mertens stated she attended a seminar on improving architectural guidelines; provided a Manual to staff; commented that public information is needed.

Community Design Commissioner Nicol commented that although developers do need guidelines, the City should not impose strict architectural standards.

Planning Commission Chairman Kweskin said the concern is the time it takes to process applications; for example, Irvine

takes nine months to process a large development based on guidelines; stated the review occurs at the Building Department level vs. board review; felt there is a need to concentrate on management enhancement of the Building Department.

Community Development Director Holloway advised that staff is preparing understandable, comprehensive guidelines so the developers know and understand the ground rules.

Mayor Veale acknowledged the need for timely processing of applications.

## REGULAR MEETING - JUNE 17, 1987

A Regular Meeting of the City Council of the City of San Clemente, conducted in the Council Chambers, Civic Center Building, 100 Avenida Presidio, was called to order by Mayor Veale at 7:10 p.m.

## INVOCATION

Rev. Jeff Craddock, of the Church of Christ, gave the invocation.

## PLEDGE OF ALLEGIANCE

Mayor Veale led the Pledge of Allegiance.

James B. Hendrickson, City Manager; Myrna Erway, City Clerk; Jeff Oderman, City Attorney; Greg Hulsizer, Assistant City Manager; Jim Holloway, Community Development Director; Bill Cameron, City Engineer; Joanne Baade, Deputy City Clerk; and certain other staff members present in the audience.

## 1. SPECIAL PRESENTATIONS

- A. Mayor Veale introduced and presented City Pins to the following recipients of Soroptomist Scholar-ships: Brenda Spring, first place; Pamela Honsberger, second place; and Julie Butler, third place.
- B. Mayor Veale presented a Certificate of Commendation to Art Holmes, Citizen of the Year.
- 2. MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 5-0, to waive reading in full of all Resolutions and Ordinances.

## 3. PUBLIC HEARINGS

A. <u>FY 1987-88 Street Lighting and Landscaping District No. 1</u>

Continued Public Hearing to consider confirming the diagram and the assessment for fiscal year 1987-88 Lighting and Landscaping District No. 1, and providing for annual assessment levy as set forth in the Engineer's Report.

City Engineer Cameron advised that a revised Engineer's Report has been distributed to Council which reflects the budget changes made by the Council on June 15, 1987 as follows: 1) \$30,000 has been added for the Los Mares median project; 2) \$41,000 has been reduced from Personnel Services; 3) \$41,000 has been added to Other Services and Charges.

Mayor Veale opened the Continued Public Hearing.

Lucile Taylor, 202 Ave. Santa Margarita, read a statement relaying her belief that the assessments in the Street Lighting and Landscaping District are not equitable; stated property owners have already been assessed sufficient revenue to repay the State Energy Conversion Loan; questioned how the revenue budgeted for loan repayment can be used for purposes other than for which it was budgeted.

There being no others desiring to speak to this issue, the Public Hearing was closed.

City Manager Hendrickson advised that staff has previously provided an in-depth response to Ms. Taylor's concerns and that the assessment district has had legal and technical review. Finance Director Porter responded to Ms. Taylor's question pertaining to budgeting procedures, explaining that a budget is an overall expenditure plan and that individual budget dollars are not binding on that particular item.

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, to:

- 1. Approve the Engineer's Final Report.
- 2. Adopt Resolution No. 87-52, entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, CONFIRMING A DIAGRAM AND ASSESSMENT AND PROVIDING FOR ANNUAL ASSESSMENT LEVY.

Council discussion ensued relative to 1) the equitability of the assessments, and 2) desire of Council to use the assessment monies for the purposes for which they were accrued.

THE MOTION CARRIED 4-1 (COUNCILMEMBER LORCH VOTING NOE).

MOTION BY COUNCILMEMBER LORCH, SECOND BY COUNCILMEMBER RICE, CARRIED 5-0, to address the following in context with the FY 1988/89 budget: 1) possibility of balancing any potential assessment inequities; 2) means of keeping the fund balance at a reasonably low level; 3) determination of the long-range goals of the District; and 4) possibility of rebuilding and/or maintaining certain areas (such as the Los Mares, Barcelona, Valencia and Esplanade medians) as soon as possible with repayment from the assessment fund.

# B. <u>Tentative Tract Map 12852 - Western Savings and Loan Association</u>

Public Hearing to consider a request to allow a 12 lot subdivision, including 10 industrial lots and 2 common lots in Planning Area 3 of the Rancho San Clemente Specific Plan.

Mayor Veale opened the Public Hearing.

<u>David Christian</u>, Project Manager for Rancho San Clemente, concurred with the contents of the Administrative Report.

There being no others desiring to speak to this issue, the Public Hearing was closed.

MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER MECHAM, to adopt Resolution No. 87-54, entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA ADOPTING A NEGATIVE DECLARATION AND CONDITIONALLY APPROVING TENTATIVE TRACT MAP NO. 12852.

In answer to Council concern expressed that the number of larger lots is decreasing, Mr. Christian explained the following large lots still remain in the Business Park; two 2+ acre lots, one 4-acre lot, eight 8-acre lots, four contiguous lots at 12 acres each, and one 30 acre lot.

THE MOTION CARRIED 5-0.

C. <u>Use Permit 86-13/Negative Declaration 87-11 - Interim</u>
Base of Pier Concession

Public Hearing to consider a request to remodel the existing structure, add seating and decking for the Pier concession. (This item was called up for review by the City Council on June 3, 1987.)

Councilmember Limberg advised that Council called up Use Permit 86-13/Negative Declaration 87-11 for review because the Planning Commission had denied the project on May 5, 1987; advised the Planning Commission reconsidered the project at its meeting of May 19, 1987 and approved a modified plan.

Mayor Veale opened the Public Hearing and there being no one desiring to speak to this issue, the Public Hearing was closed.

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER RICE, to continue Use Permit 86-13/Negative Declaration 87-11 (Interim Base of Pier Concession) to the City Council meeting of July 1, 1987. Following discussion, Councilmembers Mecham and Rice withdrew the motion on the floor.

MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER MECHAM, CARRIED 5-0 to table Use Permit 86-13/Negative Declaration 87-11 (Interim Base of Pier Concession).

MOTION BY COUNCILMEMBER LORCH, SECOND BY COUNCILMEMBER MECHAM, CARRIED 5-0, to call up for review CDC 87-19 (Patel Hotel).

## E. Fiesta Parade/Block Party

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 5-0, to adopt Resolution No. 87-53, entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE ESTABLISHING FEE SCHEDULES FOR CERTAIN SERVICES PROVIDED BY THE CITY, AMENDING RESOLUTION NOS. 62-83, 65-83, AND 83-101, AND RESCINDING RESOLUTION NOS. 69-84 AND 85-85.

## B. <u>FY 1987/88 Budget</u>

Report from the Finance Director concerning the FY 1987/88 City budget.

City Manager Hendrickson advised that the Administrative Report is reflective of all budget changes made by the City Council at its meeting of June 15, 1987.

MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER MECHAM, to adopt Resolution No. 87-57 entitled, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE ADOPTING AND APPROVING THE BUDGET FOR THE CITY OF SAN CLEMENTE FOR THE 1987-88 FISCAL YEAR.

Councilmember Lorch spoke in support of 1) City retaining an efficiency expert to review City operations; 2) establishment of a contingency fund for lower priority budget items for consideration later in the year; and 3) that a cost-savings program be implemented whereby individuals who make cost-saving suggestions are given a portion of the savings as an incentive.

THE MOTION CARRIED 5-0.

## 7. <u>NEW BUSINESS</u>

A. Zoning Amendment - New Development in Commercial and Industrial Zoning Districts

Report from the Community Development Director concerning initiation of code revisions to implement new Site Plan Review procedures for all "new development" within the Commercial and Industrial Zoning Districts.

Principal Planner Goldin reviewed the background of the proposal; recommended that Council concur with the Planning Commission and direct staff to initiate the Site Plan Review process, as outlined in Exhibit "A" of the Administrative Report.

A. L. Wulfeck, 922 Presidio, requested explanation of the term "new development"; urged that this item be advertised as a Public Hearing.

Ray Campbell, 1209 La Jolla Street, stated the business community wants to be involved in the subject zoning amendment.

Tom Davis, 207 W. Alessandro, on behalf of the Chamber of Commerce, concurred with staff's recommendation; urged Council to direct staff to continue to streamline the process; voiced opposition to the blanket conditional use permit process over all commercial/industrial projects; stated a preference for General Plan Amendments; commented on the importance of timely processing of applications.

Council advised that the proposed Zoning Amendment will be scheduled for Public Hearing after it has been refined.

MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER MECHAM, CARRIED 4-1 (COUNCILMEMBER LORCH VOTING NOE), to concur with the Planning Commission and direct staff to initiate the Site Plan Review process, as outlined in Exhibit "A" of the Administrative Report, dated June 9, 1987, and on file in the City Clerk's Office.

MOTION BY COUNCILMEMBER MECHAM, SECOND BY COUNCILMEMBER LIMBERG, CARRIED 4-1 (COUNCILMEMBER LORCH VOTING NOE) to refer to the Planning Commission the issue of a possible Zoning Amendment to address uses such as convenience stores, hotels, motels and mini-marts.

Ray Campbell, 1209 La Jolla Street, spoke in support of Contemporary Spanish architecture, as opposed to Colonial Spanish architecture.

<u>Karoline Koester</u>, 401 Via Pajaro, requested to be provided with a drainage fee report.

City Attorney Oderman advised that Sections 10.3D through 12.5 and 14.5 should have been deleted from the Ordinance; advised that this error will be corrected prior to second reading of the Ordinance.

Larry Peltier, 411-B Cazador Lane, spoke in support of the proposed Ordinance; questioned how

the Ordinance will be enforced.

Steve Kingston, 4011 Calle Abril, suggested the Ordinance be expanded to require that off street parking areas be used for vehicles and not for storage.

Al Wulfeck, 922 Presidio, requested clarification relating to the following: 1) the requirement that vehicles exceeding 7,000 lbs. not drive on certain City streets; 2) parking of mobile homes across two parking spaces; and 3) enforcement of cars being washed in streets in the Pier Bowl area.

MOTION BY COUNCILMEMBER LIMBERG, SECOND BY COUNCILMEMBER MECHAM, CARRIED 5-0, to introduce Ordinance No. 942 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE AMENDING VARIOUS PROVISIONS OF THE SAN CLEMENTE CITY CODE REGULATING THE PENALTY FOR VIOLATIONS OF THE CODE, with the understanding that Sections 10.3D through 12.5 and 14.5 will be deleted.

Councilmember Lorch suggested that the City retain an efficiency expert to review City operations.
