

CITY OF SAN CLEMENTECITY COUNCIL MINUTESADJOURNED REGULAR MEETING - JANUARY 9, 1987

An Adjourned Regular Meeting of the City Council of the City of San Clemente conducted at the Ole Hanson Beach Club, 105 Avenida Pico, was called to order at 8:30 a.m. by Mayor Veale.

ALSO PRESENT: Congressman Ron Packard; James B. Hendrickson, City Manager; Myrna Erway, City Clerk; Kelson McDaniel, Police Chief; Greg Hulsizer, Acting Community Development Director; James Barnes, Senior Planner.

CALL TO ORDER

Mayor Veale called the meeting to order at 8:30 a.m.

1. Foothill Transportation Corridor Alignment

City Manager Hendrickson relayed the City's concerns pertaining to the alignment of the Foothill Transportation Corridor, particularly the Cristianitos segment; advised there are four potential routes designated for study in Phase II, two of which are proposed to go through the City.

Senior Planner Barnes outlined the potential detrimental impact on the City if either of the two routes proposed through the City are approved; noted that at the conclusion of Phase II, the JPA will decide which alignment they will support.

Councilmember Limberg asked Congressman Packard for help in obtaining Marine Corps concurrence with Route "C"; it was noted that Route "C" would impose minimal encroachment into the Marine Base.

Congressman Packard suggested that a Resolution be submitted at the next JPA meeting, urging that Route "C" be selected and requesting legislators to support that selection; noted that General Haebel will retire this summer and urged that a meeting take place with his replacement as soon as possible; indicated willingness to submit a joint letter with the City urging elimination of Route BX (Pico Alignment).

Border Patrol

Congressman Packard advised that he will work with Mike Eggers and will set up a meeting with local cities and law enforcement agencies in an attempt to develop a coordinated policy relating to high speed pursuits and to accelerate creation of a new facility for the border patrol.

Clean Water Act

Congressman Packard opined that the Clean Water Act won't be vetoed again and that it will progress rapidly.

Highway Bill

Congressman Packard reported that the Highway Bill will be referred to Congress by January 21, 1987 and should pass by March or April of this year.

Community Development Block Grant

Congressman Packard relayed that President Reagan prefers utilization of CDBG funds, rather than revenue sharing, for community projects.

Infrastructure Responsibility

Congressman Packard advised that President Reagan wants local government to be responsible for their respective infrastructure projects; advised that Congress probably won't support the proposal in its entirety.

Offshore Oil Drilling

Councilmember Limberg thanked Congressman Packard for his successful efforts in delaying Offshore Oil Drilling. It was noted that this subject won't be addressed again until 1989.

The City will send a letter to Congressman Packard summarizing today's meeting.

Council adjourned to an Adjourned Regular Meeting to be held on Wednesday, January 14, 1987 at 7:00 p.m. in the Community Center, Ole Hanson Room. The next regular Council meeting will be held 7:00 p.m., Wednesday, January 21, 1987.


