Petition from Merchants in Downtown area re: Subject:

One-way Traffic and Angled Parking on Del Mar

During Construction Project.

The City Manager reported that some merchants on Del Mar have petitioned to make Del Mar a one-way street, with parking on one side, for the duration of the construction project; Staff including fire, police and traffic engineering personnel have the situation and met with Chamber of Commerce and reviewed Downtown Business Association representatives to hear their concerns and suggestions regarding the one-way proposal.

Lincoln Rosay, DBA President, and Chamber of Commerce repre-

sentatives advised Council most of the concern on this matter no longer exists.

MOTION BY COUNCILMAN DIEHL, SECOND BY MAYOR LIMBERG, CARRIED 4-0 to retain the present policy for traffic and parking on Avenida Del Mar.

Subject: Community Relations and Public Information Efforts.

The City Manager advised a Public Information Committee composed of the Assistant to the City Manager, the City Clerk, the Fire Marshal, and the Recreation Supervisor was established to elevate the importance of the public information function. The committee has expanded the format of the San Clemente Municipal Report and Recreation Program, publicized major reconstruction projects, and provides information to those affected by Council Agenda items.

## Joint Meeting Agenda Items

Larry Wohlfarth, Parks & Recreation Commission, suggested agenda items be sent out in advance of the next joint session

MOTION BY COUNCILMAN DIEHL, SECOND BY MAYOR LIMBERG, CARRIED 4-0 that any items the Commissions/Committee wish to discuss at a Joint Session are to be submitted to Staff the first Commission/Committee meeting of the month in which the Joint Session is to be conducted.

## ROUND TABLE DISCUSSION

Planning Commission

Commissioner Saunders voiced concern for the use of reclaimed water in the backcountry and the restrictions placed upon the usage. Commissioner Kweskin stated the city has no standards for reclaimed water.

<u>James Higgins</u> requested a report about the backcountry projects and freeway.

Parks and Recreation Commission
Commissioner Mitchell advised of the Commission's concern about accepting land and no fees from the backcountry developers.

Golf Course Committee

Tom Dunn announced the second golf course is not a dead issue; the State has taken a very strong position on developing 3,000 acres of Camp Pendleton property for recreational purposes, including a golf course, which is part of the San Onofre State Park master plan. Advised the April fee increase at the golf course has generated \$221,000 through December; the fees are still low and very competitive with other courses; the General Enterprise Fund now has \$887,000 which could help finance a second golf course, or a first-class clubhouse.
