ITEMS FROM COUNCIL MEMBERS

Mayor Carr gave a report on the Legislative Conference held in Sacramento on June 11-12 with the theme being "A Final Lobbying Effort to Push Long-Term Finance Legislation to the Governor's Desk"; that the issues affecting cities which are being considered in the Legislature this year have the potential of making significant changes in the way local government functions in California; that foremost among these issues is the future fiscal relationship between cities and the State; and that other critical issues include legislation dealing with housing, infrastructure financing, community and economic development, employee relations, land use, tort reform, and toxic wastes. He further noted that considerable time was spent on Jarvix IV and that any tax authorized after August 15, 1983 is subject to roll back if the measure passes, such as the 2% bed tax increase in this City; noted that the State Chamber of Commerce, League of California Cities and other groups are going on record in opposition to Jarvis IV. Further, there_is no opposition to the bills introduced by the assembly and senate, however, they are not moving; that both houses have passed the budget; and that the Governor has signed into law SB 2333 which gives local control as to the sale of safe and sane fireworks.

The Council continued their review of the 1984-85 budget and during the course of the meeting on a page by page basis reviewed Enterprise Funds, Internal Service Funds, Special Revenue Funds, Capital Project Funds and the Redevelopment Agency Budget.

In response to query from Mayor Carr as to how much as of June 30, 1984, the RDA will owe the General Fund, the Finance Director advised \$250,700.

Staff responded to questions from Council members regarding various budget items and their relationship to the overall budget.

In consideration of the request submitted by San Clemente Seniors for \$10,000 to help fund the seniors meal program, IT WAS MOVED BY COUNCILWOMAN KOESTER, SECONDED BY COUNCILMAN LIMBERG to appropriate \$5,000 for one year only to this program.

Following comments and discussion by Council members, IT WAS MOVED BY COUNCIL-MAN MECHAM, SECONDED BY MAYOR CARR, AND UNANIMOUSLY CARRIED to table the motion until the meeting of 6-20-84.

With reference to the Chamber of Commerce request for \$20,000 for the proposed tourist and convention bureau to be funded from the 2% increase in transient occupancy tax, IT WAS MOVED BY MAYOR CARR, SECONDED BY COUNCILMAN MECHAM, AND UNANIMOUSLY CARRIED to continue the matter to the meeting of 6-20-84.
