50bled: 49 - Request for Ordinance Providing for Calling of Special Elections to Fill Council Vacancies.

IN RE: Robert Flynn's presentation and request that Council adopt an ordinance which provides for the calling of special elections to fill Council vacancies.

Following Mr. Flynn's presentation, IT WAS MOVED BY COUNCILMAN AHLMAN, SECONDED BY COUNCILMAN KALSCHED to set a public hearing for April 16, 1980, to consider the manner of filling vacancies on the City Council.

Mayor Hamm philosophized that he felt Council was giving away their right to decide how to replace City Council members; that it is a very important part of their legislative power; that each situation is different; that they should consider the cost of special elections; that this could result in a long time to go with only a four-member City Council; and important City business could be delayed when a majority agreement cannot be reached.

Following further comments, the Mayor then called for the QUESTION WHICH CARRIED UNANIMOUSLY.

Marilyn Ditty, Senior Citizens Coordinator, expressed her gratitude to the City Council and Staff for diligently securing the \$200,000 in HCD funds for construction of a neighborhood community center in conjunction with the library; that the Board of Supervisors also approved \$110,000 for the purchase of land for the eventual construction of affordable housing for the elderly and handicapped, and \$25,000 for a housing rehabilitation program for San Clemente citizens. Mrs. Ditty emphasized that because of the direct funding primary emphasis must be on services to seniors and urged that construction of the project proceed as rapidly as possible.

Lee Steelman, representing the South Orange County Community Services Council, made a presentation and request for space in the multi-purpose Library facility, noting that the services should not be divided according to age and that there should be space in the building for all ages and to serve other community needs.

UNFINISHED BUSINESS

5ublect: 77 - Beach Cleaning Equipment

IN RE: Report from Interim Marine Safety Director and City Manager recommending purchase of a Beach Queen sanitizer from the Beach Queen Corporation in the amount of \$26,273 and a model 2840 John Deere tractor from Escondido Machinery Company in the amount of \$22,790.

Councilman Ahlman requested certain clarification as to the quotation on the tractor which Staff responded to, following which IT WAS MOVED BY COUNCIL-MAN AHLMAN, SECONDED BY COUNCILMAN HURLBUT, AND UNANIMOUSLY CARRIED to waive formal bid procedure pursuant to Municipal Code Section 5-6(h); approve the purchase of the Beach Queen sanitizer from Beach Queen Corporation (\$26,273) and a model 2840 John Deere tractor from Escondido Machinery Company (\$22,790) for a total price of \$49,063; and appropriate necessary funds from unappropriated reserve.

Councilwoman Koester commended the Interim Marine Safety Director for securing a better price than originally presented, and in regard to this purchase, inquired if the City Manager anticipated any budget problems in view of the large capital expenditure. Mr. Caravalho replied that he has not had an opportunity to review the entire budget, however, he is supportive of the purchase and in order to maintain the beaches at the proper level, the equipment should be purchased.

The Mayor then called for THE QUESTION WHICH CARRIED UNANIMOUSLY.

Subject: 64 - Report from Ocean Festival Committee.

IN RE: Communication from Ocean Festival submitting further information and expressing appreciation for the \$2,000 commitment of funds toward the promotion of the Ocean Festival 1980, and submitting an explanation and request for an additional \$3,000 to be used for promotion, advertising and related expenses for said festival.

IT WAS MOVED BY COUNCILMAN AHLMAN, SECONDED BY COUNCILMAN HURLBUT, AND UNANIMOUSLY CARRIED to refer the matter to the budget study sessions.

Subject: 105 - Request for Extension of Time on Tentative Tract Nos. 10533, 10595 and 10596.

IN RE: Memorandum from Subdivision Committee Chairman referring to the request from Estrella Properties, Ltd. for an 18-month extension for Tentative Tract Nos. 10533, 10595, and 10596; and noting that Council previously granted an 18-month extension for Tentative Tract No. 10417.

IT WAS MOVED BY COUNCILMAN AHLMAN, SECONDED BY COUNCILMAN KALSCHED to approve the recommended modifications and refinements of conditions as recommended by the Subdivision Committee and pursuant to that action grant the 18-month extension for Tentative Tract Nos. 10533, 10595, and 10596; and subject to further modifications as follows:

Condition #8, second paragraph - "That streets in the equestrian estates area be constructed pursuant to standards as to width, curbs, street lighting, structures, walks, trails, etc., which shall be developed as a part of the equestrian estate management plan, as required in condition #27. All other streets shall be as per code;" Condition #12 - "Street grades shall not be less than 2% minimum, except Camino de los Mares;" Condition #14 - "Approval of the green-belt/water course along Camino de los Mares is contingent upon the filing of a final tract map and, at that time, approval of drainage structures as required to meet Orange County Flood Control District criteria for protection against a 100-year storm, and to the satisfaction of the City Engineer. All costs for improvements for drainage facilities and structures on-site shall be borne by the developer. Drainage fees may be used for down-stream improvement purposes as necessary. Additionally, the developer shall notify Cal-Trans, in writing of the need to enlarge the drainage duct under I-5, if necessary, to accommodate anticipated acceleration of run-off generated by up-stream development. The on-site channel shall be lined with a non-erodible liner to accommodate low-flow water (5-year storm basis), or as otherwise approved by the City Engineer for green belt protection and preservation. The City and the developer shall work together to obtain funds for down-stream improvements."

Councilwoman Koester requested that the applicant be heard, and Mayor Hamm stated his reason for being against these modifications.

A SUBSTITUTE MOTION WAS MADE BY MAYOR HAMM, SECONDED BY COUNCILWOMAN KOESTER, to grant an 18-month extension on Tentative Tract Nos. 10533, 10595, and 10596 with the previously approved conditions.

Comments by Leo Fitzsimon, representing Estrella Properties, are briefly noted as follows: That they do not disagree with the conditions as it is a large project; that they are not adverse to discussing the conditions but prefer to the retention of the original conditions; that the City always has the right to raise fees; and that a hydro analysis should be done on the down-stream channel all the way to the ocean, and that they would be willing to undertake this study.

Mayor Hamm reiterated that he objected to the whole idea of trying to put any additional conditions on this tract; that after many, many hours of deliberation the original conditions were satisfactory with the Planning Commission and City Council and he can see no reason to belabor the point as the developers have paid their way.

Following further discussion, the Mayor called for the SUBSTITUTE MOTION WHICH FAILED TO CARRY with Councilmembers Ahlman, Hurlbut, Kalsched, and Koester voting "NO."

The Mayor then called for the ORIGINAL MOTION WHICH CARRIED with Mayor Hamm voting "NO."

5vblech: 73 - Request for Support from City for Equipment and Personnel to Present La Cristianita Pageant.

IN RE: Communication from La Cristianita Pageant Association requesting support from the City in the form of equipment and personnel to help present the La Cristianita Pageant and outlining areas where aid is requested.

IT WAS MOVED BY COUNCILMAN AHLMAN, SECONDED BY COUNCILMAN HURLBUT, AND UNANIMOUSLY CARRIED to approve the request.

ITEMS FROM CITY MANAGER

Subject: 109 - Termination of State of Local Emergency.

IN RE: Report from Fire Protection Director and City Manager recommending that the State of local emergency be terminated.

IT WAS MOVED BY COUNCILMAN AHLMAN, SECONDED BY COUNCILWOMAN KOESTER, AND UNANIMOUSLY CARRIED to terminate the state of local emergency.

Subject: 63 - Proposed Library/Senior Citizen Facility.

IN RE: Progress report on the library construction.

The City Manager reported that Staff is working diligently to see that the project is constructed; that at this point there is no new information to report; that we are awaiting to hear from the architect who designed the Seal Beach Library with his suggestion as to a cost estimate; and that the City Attorney, Finance Director and he are in the process of opening an escrow account; that \$1 million is committed for the entire project and these funds are adequate for developing the entire facility. He further advised, that he has been communicating with the Library Committee, composed of Council members Ahlman and Hurlbut, and others and inquired whether Council wishes him to continue to try and work out some arrangement with the architect of the Seal Beach Library.

IT WAS THEN MOVED BY COUNCILMAN AHLMAN, SECONDED BY MAYOR HAMM for the City Manager and Staff he is working with to proceed along the same lines, and commending them for the good work that has been done.

Councilwoman Koester requested firm figures be obtained from the County, plus square footage of building and the cost per square foot; and Councilman Ahlman reiterated this is why we must proceed expeditiously due to the ever increasing costs.

The City Manager suggested that since there is a substantial interest in the community in this project, an Ad Hoc Committee be formed for the next several months whereby they could meet with the various groups to receive their input and help resolve any differences that might exist.

The Mayor then called for THE QUESTION WHICH CARRIED UNANIMOUSLY.

Subject: 85 - Preservation of Coastal Bluffs and Historic Sites.

IN RE: Report concerning problems of bluff erosion and Dr. Atherton's concerns of historical preservation.

IT WAS MOVED BY COUNCILMAN AHLMAN, SECONDED BY MAYOR HAMM, AND UNANIMOUSLY CARRIED to receive and file the report.

Subject: 39 - Study Session for City Council.

IN RE: Recommendation of the City Manager for a Council Study Session.

The City Manager advised that this Study Session would be an opportune time to discuss with Council the present budget while still in the process of preparing next year's budget; an opportunity to discuss the sewer bond issue; plus other issues; and suggested that the meeting be held at the Community Center.

IT WAS THEN MOVED BY MAYOR HAMM, SECONDED BY COUNCILMAN AHLMAN, AND UNANIMOUSLY CARRIED that a Study Session be set for 7:00 P.M., April 30, 1980, in the Community Center.

Councilwoman Koester thanked the members of the current Council, noting that unfortunately there have been some unhappy occurrences, but not here on the dias; that the policies voted on have worked well; that the Council has done a good job, and expressed a special thanks to the Mayor for his conduct of the meetings.
