DECLARATION OF ELECTION RESULTS

In accordance with Resolution No. 35-80, the canvass of the returns of the election held April 8, 1980, was made on April 10, 1980, and the Clerk then read the results and presented his "Certificate of Canvass".

Upon motion of Councilwoman Koester, seconded by Councilman Ahlman, and unanimously carried, RESOLUTION NO. 35-80, BEING A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN SAID CITY OF SAN CLEMENTE ON THE 8TH DAY OF APRIL, 1980, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW was regularly introduced, passed, and adopted.

RESOLUTION NO. 35-80

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN SAID CITY OF SAN CLEMENTE ON THE 8TH DAY OF APRIL 1980, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW

WHEREAS, a regular general municipal election was held and conducted in the City of San Clemente, County of Orange, State of California, on Tuesday, the 8th day of April, 1980, as required by law; and

WHEREAS, notice of said election was duly and regularly given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects said election was held and conducted and the votes cast thereat, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in cities; and

WHEREAS, pursuant to Resolution No. 28-80, adopted the 19th day of March, 1980, the City Clerk of the City of San Clemente canvassed the returns of said election and has certified the results to this City Council, said results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

That as a result of said election, a majority of the qualified voters voting on said measure relating to widening of El Camino Real did not vote in favor thereof, and that said proposition was not carried, and shall not be deemed adopted and ratified.

That as a result of said election, a majority of the qualified voters voting on said measure relating to Council districts did not vote in favor thereof, and that said proposition was not carried, and shall not be deemed adopted and ratified.

That as a result of said election, a majority of the qualified voters voting on said measure relating to appointive City Treasurer did not vote in favor thereof, and that said proposition was not carried, and shall not be deemed adopted and ratified.

SECTION 7. The City Clerk shall enter on the records of the City Council of said City a statement of the result of said election, showing:

- (1) The whole number of votes cast in the city;
- (2) The names of the persons voted for;
- (3) The measures voted upon;
- (4) For what office each person was voted for;
- (5) The number of votes given at each precinct to each person, and for and against each measure;
- (6) The number of votes given in the city to each person, and for and against each measure.

SECTION 8. That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe thereto and file the same in the office of the City Clerk. Whereupon, each and all of said persons so elected shall be inducted into the respective office to which they have been elected.

SECTION 9. That the City Clerk shall certify to the passage and adoption of this Resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute of passage and adoption thereof in the records of the proceedings of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.

OATH OF ALLEGIANCE

Councilman Hamm expressed his appreciation; then remarked it has been a stormy two-year experience; that there has been a tremendous amount of controversy in the community; that this is a brand new City Council sitting here from the time he was elected and he would challenge them to bury all the differences that seem to be the problem with the City and join together to try and make the City a better place to live and do business. He further added that he would like to continue in his Council role, but business pressures prohibit that. He also thanked all of the persons who have supported him, and wished the new Council good luck.

At this point the Mayor granted the City Clerk a point of "personal privilege" and he introduced the members of his family who were present.

ADJOURNMENT

There being no further business, IT WAS MOVED BY COUNCILMAN MECHAM, SECONDED BY COUNCILMAN LIMBERG, AND UNANIMOUSLY CARRIED to adjourn the meeting at 7:25 P.M.
