PUBLIC HEARINGS

Subject: 48 - Consideration of Formation of a Geological Hazard Abatement District.

IN RE: Public Hearing to consider the formation of a Geological Hazard Abatement District in several areas of the City to help resolve the problems associated with land subsidence and endangered properties, as provided for under the provisions of Section 26500, et seq. of Public Resources Code.

The City Manager explained the procedures and provisions of such an abatement district which allows local government involvement without fear of creating liability, and noted that areas in the City that could conceivably benefit from the formation of such a district are the Calle Nina area, the bluffs above El Camino Real on the coast, Salvador and Buena Suerte, the Broadmoor tract, and Harbor Estates.

Following a general question and answer period, the Mayor then opened the public hearing and the main comments made during the lengthy hearing are briefly summarized as follows:

Wayne Patterson advised that his area is in desperate need of the City's involvement in implementing repairs to the hillside; that as noted in their letter they are not suggesting that the City foot the bill but merely insist by ordinance or some other means that the slopes be properly repaired and maintained in the most geologically safe manner; and traced the efforts he has made to organize homeowners in the area after a mudslide nearly buried his property in January of 1978, and attempts to have the City resolve the matter under public nuisance abatement procedures. Gerald Gibbs expressed various comments and advised that residents in the Calle Nina area have spent many thousands of dollars to try to correct a land slippage problem on their own, however, they have run out of resources and need assistance from the City in resolving the matter. William Duncan stated he had \$10,000 worth of slope improvements on his property last fall; that he now has another \$15,000 - \$18,000 in damages and any help the citizens can receive from the City will be deeply appreciated. Woodrow Higdon stated that the geological hazard abatement district should be used as a last resort; that costs are expensive and the City should be looking at preventive measures to prevent slope failures. William Gallaher, noted he was in favor of fixing hillside; inquired as to whether the City could receive Federal grants for this type of repair; and noted that the street in the Calle Nina area appears to be showing a split. Staff advised that we are continuing to pursue Federal funding; that a report has been submitted but to date has been denied; and noted that the public street shows no sign of failure or stress. Bernard Beckerlegge noted that in forming this type of district it is similar to creating a mutual insurance company and suggested the main problem would be the matter of equity...

The Public Hearing was then closed and the Council discussed the issues at length, following which IT WAS MOVED BY COUNCILMAN O'KEEFE, SECONDED BY COUNCILMAN MECHAM, AND UNANIMOUSLY CARRIED that Staff be directed to cooperate with the home owners in each one of the endangered areas to assist them in preparation of petitions, if requested, for the formation of Abatement Districts; and to consider favorably in principle requests that the City participate in those districts to an extent that would recognize the normal City expenditures in the event no districts were formed and a failure occurred.

COMMUNICATIONS FROM COMMISSIONS AND COMMITTEES

Subject: 106 - Bus Benches

IN RE: Communication from Traffic and Parking Commission concerning the bus benches located throughout the City and recommending (a) that City Council terminate the contract with the Bench Ad Company as soon as practicable; (b) that the various service clubs, in conjunction with the Chamber of Commerce, be contacted to determine their interest in providing bus benches; and(c) that the San Clemente Seniors be contacted and polled as to what key areas in the commercial district they would like to have bus benches installed.

IN RE: Communication from Planning Commission concurring with Traffic and Parking Commission's recommendation for termination of the bus stop bench advertisements.

IN RE: Communication from San Clemente Seniors requesting that Council leave the bus benches that are currently located in the City.

IN RE: Communication from Mr. & Mrs. Karl Wray objecting to the advertising type benches presently located at bus stops in the City.

Lengthy discussion is briefly summarized as follows:

Councilman O'Keefe suggested it might be feasible to modify the contract to require the advertising company to remove the benches in any location where the weighborhood residents object; and that some civic group, or volunteers work ogether toward replacing these benches without any advertising. Karl Wray reviewed his letter and objected to the permanent benches on Ola Vista where some of the benches were installed on sidewalks and in front yards; noted that in the business and commercial areas he felt advertising on the benches was not Djectionable but such advertising on benches in residential areas should not Tlowed. Bernard Beckerlegge noted the amount of money spent to repair pot ., and if smaller buses were used the money saved could buy benches without uising. G. Wilson Bell expressed extensive comments on behalf of the remente Seniors and suggested that the bus benches should be replaced and when some organization or individual will replace the benches; and namested that the three benches that were removed on Ola Vista be returned. Domenichini objected to the advertising on the benches in the ter deadial areas noting that it created an aesthetic problem; that some γf standard should be maintained; and suggested that the Chamber of the fee act as the central agency for forming a group to resolve the Mea. Flora-Lee Wray expressed various concerns about the advertising strongs; that she wanted to work very hard to get better benches through fund leas; and noted the grafiti problems that have occurred on the benches.

iteriff, Bench Ad Co. representative, advised that his company tries to all flexible and removed some of the ads from the benches on Ola Vista; and advertising is the means by which they are able to place these benches in the cuty without cost; and that they are most interested in remaining in San Clemente. In response to servicing of benches once a month, he advised that they attempt to do this and will concentrate on benches displaying grafiti, and urging citizens to report where these benches are as they will prosecute anyone who tries to deface or destroy the benches.

Following further discussion and Council deliberation, IT WAS MOVED BY COUNCILMAN MECHAM, SECONDED BY COUNCILMAN LIMBERG, AND UNANIMOUSLY CARRIED not to terminate the Bench Ad Contract at this time; that a Citizens Committee be established which will embody all interested parties to study this particular problem and report back to Council within a 90-day period; that if agreeable the Chamber of Commerce be the focal point with Mrs. Domenichini acting as Chairperson with volunteers from groups such as Senior Citizens, neighborhood groups affected, representatives of the business community, etc.

Councilman O'Keefe suggested that a communication be sent to OCTD concerning use of smaller buses thus preventing tearing up the residential streets. The clerk noted a similar request had been previously made and it was suggested a follow up letter be sent to check on the status of the request.

The Bench Ad representative inquired as to the three benches they had removed from the Ola Vista area due to the complaints, and IT WAS FURTHER MOVED BY COUNCILMAN O'KEEFE, SECONDED BY COUNCILMAN MECHAM, AND UNANIMOUSLY CARRIED that no action be taken to request the Bench Ad Company to replace the benches for the 90-day period during which the Committee is acting and hoping the Committee will come back with a recommendation on the three benches within that period.

Subject: 113 - Reservoir II-B Projects - Budget Review.

IN RE: Report from Public Works Director-City Engineer and City Manager advising that a complete review has been made of the budget status relating to construction contracts and engineering agreements involved in the Reservoir II-B project so that any additional appropriations required can be made in one final budget adjustment.

Following Staff response to questions, IT WAS MOVED BY COUNCILMAN LIMBERG, SECONDED BY MAYOR KOESTER, AND UNANIMOUSLY CARRIED to approve a budget appropriation for cost of design and construction engineering services provided by Toups Corp., under agreements previously approved by Council, for which no budget appropriation was previously made; said appropriation to be in the amount of \$128,990 to be transferred from the Water Utility Fund to Account #70-469-7740-302.

Subject: 48 - Drainage Problems Relating to Lots 152 through 157, Tract No. 4469.

IN RE: Communication from Harold G. Wisehart, et al, owners of Lots 152 through 157, Tract No. 4469, requesting the City to correct a drainage deficiency on private property contending that the City should correct an error in the original construction of a carry off ditch.

Mr. Wisehart reviewed the history of the drain problem and spoke in support of the request and, following comment by the City Attorney, IT WAS MOVED BY COUNCILMAN MECHAM, SECONDED BY COUNCILMAN LIMBERG, AND UNANIMOUSLY CARRIED to deny the request by the property owners to solve the drainage problem as it is a private property matter.

Subject: 106 - Traffic Problems on East San Gabriel and East San Pablo.

IN RE: Communication from Wil Clark, et al, expressing concerns over the increasing traffic and related problems on San Gabriel and San Pablo; noting that these two streets provide the only public access into Mariners Point development; and submitting certain questions on inquiry as to where solutions will be provided.

Lengthy comments are summarized as follows:

Wil Clark advised that he represented 93 homes in the area and reviewed his letter listing numerous problems associated with the excess traffic. Ruth Burkhardt voiced concern as to the traffic congestion on Avenida San Pablo, air pollution, potholes in the street, degrading of the homes and urged reasonable steps be taken to provide another access route to new tracts. Chuck Mitchell urged the City Council to address the issues due to the urgency of the matter. Byron Thompson stated that there is dire need for proper egress and ingress to back country development other than San Pablo; that the City should consider a moratorium on further development until Avenida Pico or some other access is developed to take care of the traffic; inquired whether any provision for emergency evacuation of the area is available; and requested that a 3-way stop be provided on the corner of San Pablo and Acapulco. Wil Clark made further comments urging consideration of extending Avenida San Pablo to tie in with Avenida Pico, and a moratorium on Rancho San Clemente development until adequate access is provided.

Following Council comments and discussion, IT WAS MOVED BY COUNCILMAN MECHAM, SECONDED BY COUNCILMAN LIMBERG, AND UNANIMOUSLY CARRIED that the matter be referred to the City Manager for his recommendation back to the Council within 60 days, including a report back as to the impact of a moratorium on building in this particular area, (being any new development that would have Avenida San Pablo/San Gabriel as its primary ingress and egress).

Subject: 97 - New Sewer Lift Station in Cyprus Shores

IN RF: Communication from Quayle Plumbing suggesting that the existing pump station at Cyprus Shores should be repaired and the \$42,500 which was reimbursed to Cyprus West for one-half of the cost of a new lift station would be better spent on street repairs.

Upon request, A. L. Wulfeck gave an explanation noting that this was to benefit the City and not Cyprus West.

IT WAS MOVED BY COUNCILMAN O'KEEFE, SECONDED BY COUNCILMAN LIMBERG, AND UNANIMOUSLY CARRIED that the City be represented at State Park Commission hearings; that the Parks & Recreation Commission nominate someone to attend; and that this does not preclude the City Manager from designating a member of Staff to also attend if he deems it appropriate.

NEW BUSINESS

Subject: 55 - Resolution No. 40-80 Requesting Additions to the Federal-Aid Urban System.

IN RE: Report from Public Works Director-City Engineer and City Manager recommending adoption of a resolution for submittal to the Orange County Transportation Commission requesting inclusion in the Federal-Aid Urban (FAU) System of certain streets to establish eligibility for future funding of street improvements.

Upon motion of Councilman Mecham, seconded by Councilman O'Keefe, and unanimously carried, RESOLUTION NO. 40-80, BEING A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, REQUESTING ADDITIONS TO THE FEDERAL-AID URBAN SYSTEM, was regularly introduced, passed, and adopted.

Subject: 105 - Request for Subdivision Agreement Extension - Tract No. 8575.

IN RE: Report from Public Works Director-City Engineer and City Manager advising that San Clemente Estates, dba Linda Mar Estates, received approval for an extension of their Subdivision Agreement to 8-30-80 with the stipulation that the City Engineer engage a geological firm to conduct a geological investigation of the project, with the cost to be borne-by the developer; and noting that another developer may be acquiring the property and is requesting extension to 8-3-82.

Lengthy discussion is briefly summarized as follows: Tim Paone, representing the present owners of Tentative Tract 8575, requested additional time for completion of all flood hazard mitigation plans and work; noted that the tract is presently in bankruptcy and that a change of ownership will allow development to take place; that they are willing to work out some arrangement to resolve the flood hazard mitigation problems; that fees have been paid to the City on the project; and that as to a comment concerning possible reversion to acreage for this tract such is available only if no lots have been sold or no improvements have taken place; and if reverted to acreage, the City would owe refund of many fees to the developers.

The City Manager also advised that the City is in the process of filing for reimbursement for expenditures relative to storm damage, and in order to receive this reimbursement mitigation plans for any flood hazard area need to be prepared in order for the City to receive disaster relief.

Following extensive discussion, IT WAS MOVED BY COUNCILMAN O'KEEFE, SECONDED BY MAYOR KOESTER to refer the matter to Staff for report back within 30 days as to what alternatives are available to the Council and what the consequences may be.

Council expressed concern that certain improvements which have been pending for three years have not materialized; that there is a history of letters from the City to the developer with no responses; and that there was a lack of geological information on the property.

Keith McWilliams, bankruptcy attorney, urged extension of the agreement in order for the new owners to take care of the flood control problems; that with the reorganization of the tract a viable plan for development of the property has been prepared; and noted that the City cannot take action to revert property back into raw acreage without litigation in the bankruptcy court.

Following further discussion, the MAYOR CALLED FOR THE QUESTION WHICH CARRIED UNANIMOUSLY.

Subject 99 - Award of Contract for Del Mar-Ola Vista Traffic Signalization
