CONSIDERATION OF A RESOLUTION APPROVING THE COASTAL ADVISORY COMMITTEE FISCAL YEAR 2023-2024 WORK PLAN

Fiscal Impact:

There is no direct fiscal impact associated with the creation of the work plan. However, implementation of the work plan may include consultant fees and staff time, which are anticipated to be minimal. Projects that result in the higher project costs will return to the City Council for funding approval.

Summary:

Before the City Council is the Coastal Advisory Committee's (CAC) proposed FY 2023-24 Coastal Advisory Committee Work Plan (Work Plan). The purpose of the Work Plan is to identify project priorities and guidance on CAC objectives from the City Council until October, 2024.

Background:

On July 18, 2023, the City Council adopted Ordinance No. 1753 creating a five-member Coastal Advisory Committee. On December 5, 2023, the City Council adopted Ordinance No. 1768 expanding the Coastal Advisory Committee from a five-member committee to a seven-member committee.

Pursuant to San Clemente Municipal Code Chapter 2.29.015, the mission of the Coastal Advisory Committee is to, "enhance the preservation and replacement of sand on City beaches, and where necessary, restore the quality of the coastal water resources and ensure proper and efficient use of the beaches, surf zone and coastal area for the benefit of present and future generations."

Further, the Committee, "shall advise the City Council by making recommendations on policy, programs and regulations related to the City's coastal environment and resources."

At its February 20, 2024 meeting, the City Council provided the following direction on the CAC work plan for Fiscal Year 2024:

- Get Sand Advise the City Council on getting sand for San Clemente beaches with a focus on the Sand Compatibility and Opportunistic Use Permit (SCOUP) concerning site locations for opportunistic sand and feasible methods of delivery.
- 2. Keep Sand Advise the City Council on best methods to retain sand that are being proposed and/or should be proposed by the nature-based solutions study.

3. Water Quality - Advise the City Council on ways to improve water quality, specifically at Poche Beach.

At its March 21, 2024 meeting, the CAC considered proposed work plans that included the City Council direction, and recommended the Work Plan provided as Attachment 2.

Council Options:

- Adopt Resolution No. 24-51, which would approve the CAC FY 2023-2024 Work Plan, and determine that the activities in the FY 2023-2024 Work Plan are exempt from the California Environmental Quality Act (CEQA).
- Modify and adopt Resolution No. 24-51 with changes to the CAC FY 2023-2024 Work Plan.
- Continue the item with direction to provide additional information.
- Do not approve the CAC FY 2023-24 Work Plan.

Environmental Review/Analysis:

An environmental analysis has been conducted on all items on the CAC's FY 2023-2024 Work Plan and has determined that none of the items constitutes a "project" pursuant to CEQA Guidelines Section 15378 (14 CCR § 15378). Pursuant to CEQA Guidelines Section 15060(c)(2), an activity is not subject to CEQA if the activity will not result in a direct or reasonably foreseeable indirect physical change in the environment (14 CCR § 15060).

The below table summarizes the work plan items and recommended CEQA findings for each item:
