# SECOND AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT FOR Electronic Document Imaging Services

#### RECITALS:

- A. City and Consultant entered into that certain Professional Consultant Services Agreement for Electronic Document Imaging (the "Original Agreement") on April 6, 2021.

Exhibit A to the Agreement is hereby amended such that Consultant shall also perform those Services described in <a href="Exhibit "A" to this Second Amendment">Exhibit "A"</a> to this Second Amendment, which exhibit is attached hereto and fully incorporated herein by this reference.

<u>Section 3.3.1</u> of the Agreement is hereby amended to update the total compensation not-to-exceed amount to \$50,000.

Except as expressly amended by this Second Amendment, the remaining portions of the Agreement shall remain in full force and effect.
