PRINTING OF 5,000 CITY MAPS \$129.00

PETITION RECOMMENDING THAT CITY RETAIN BEACH CLUB FACILITIES

PETITION FROM A SEGMENT OF THE YOUNGER GROUP recommending that the City retain the facilities of the Beach Club and pool, was read. Mr. Carrick stated that he felt the petition reflected the opinion of the majority of San Clemente citizens and moved that the City Council withdraw Ordinance No. 212 requesting that the matter be placed on the November The motion died for lack of a second, ballot. whereupon Mayor Read ordered the petition filed.

ORAL COMMUNICATIONS

NEAR HIS MOTEL

FRANK DAILEY'S Mr. Frank Dailey, owner of a motel at COMPLAINT RE the corner of Delores Avenue and Highway 101, LOADING TAXICABS addressed the Council stating that taxicabs were loading passengers on the south side of Delores Avenue adjacent to his motel, and objected to the noise made by the cab radios and disturbances made by the passengers.

> Mr. Ray Campbell, owner of the Taxicab Company, addressed the Council and stated that he had loaded passengers from the north side of Delores Avenue for several years and that only recently has Mr. Dailey objected to the Marines congregating on the south side of the street and complained to the Marine authorities, which resulted in an M.P. having been stationed at the corner to keep the Marines from standing on property which is owned by the City.

Mr. Campbell further stated that this situation has affected his business so that now he is forced to load passengers from the south side of the street in order to protect his business.

Mr. Dailey was advised by the City Attorney that he did not have the right to order anyone off property which does not belong to him, and recommended that the City survey this property and determine the sidewalk line, making a line of demarcation between City property and Mr. Dailey's property, and advise Mr. Dailey to obtain permission from the City of San Clemente to maintain shrubs and grass on City property which is intended as a sidewalk.

Mayor Read directed that the City Attorney advise Mr. Dailey as to the City's position after the City Engineer, Mr. William Ayer, has surveyed and established the property line.

STREET LIGHT

The Chief of Police recommended that a street light be installed at the alley, which, he felt, would keep Marines from congregating near Mr. Dailey's property.

WIDENING OF

The City Engineer recommended that 250 square INTERSECTION feet of the south-east corner of Santa Barbara and AT OLA VISTA, Ola Vista Avenues be purchased to allow for the widening of the intersection, and also recommended that a like area be purchased at the south-east corner of Madrid and Ola Vista Avenues.

WIDENING OLA VISTA

Councilman Blakelock stated that the Planning Commission had recommended, some months ago, that steps be taken to acquire property between Madrid and Rosa Avenues for the purpose of widening Ola Vista. At that time there were no homes on the east side of Ola Vista. However, in recent months two homes have been built which would make the widening of the street very costly, and Councilman Blakelock recommended, as an alternative, the acquisition of property at the two intersections of Madrid and Santa Barbara in order to eliminate the traffic hazard.

UPON MOTION OF COUNCILMAN BLAKELOCK SECONDED BY COUNCILMAN HEMPEL the City Engineer was directed to furnish the City Clerk with a description of the property needed, and the City Clerk was directed to correspond with the owners of the property with a view toward acquiring same.

Report of the activities of Mr. Charles Elterman, Custodian of the Community Club House, the month of August, 1952 was read and ordered filed.

SPT. OF PUBLIC WORKS

REQUEST FOR Report of Councilman Blakelock concerning the ASSISTANT FOR need for an assistant for Mr. Parker, Superintendent SPT. OF of Public Works. It was pointed out that since the death of Mr. Bennett, Mr. Parker has been running the Public Works' Department by himself, and with the expansion of the City, the new work being undertaken including the replacement of water lines and the resurfacing of streets, etc., it is necessary for Mr. Parker to have assistance.

> IT WAS MOVED BY COUNCILMAN BLAKELOCK SECONDED BY COUNCILMAN HEMPEL that the City Clerk and the Superintendent of Public Works be empowered to investigate the possibility of finding a person

with an engineering background who could be employed on a part time basis, initially, as as assistant to Mr. Parker.

STREET SIGNS

In reporting on the purchase of street signs, Councilman Blakelock stated that we have in the budget an allocation of about \$1,500 for approximately 100 street signs, and that he had taken careful check of the intersections on the secondary highways throughout the City, and found that the number of sign posts necessary to sign these routes amounted to 120.

REQUEST FOR BIDS ON IN-STALLATION OF STREET SIGNS IT WAS MOVED BY COUNCILMAN BLAKELOCK, SECONDED BY COUNCILMAN FORTUNE AND UNANIMOUSLY CARRIED that the City Clerk be empowered to ask for informal bids on sign boards and the necessary pipe for these intersections, and purchase same on the informal bids, which will be less than \$1,000, and to fill these orders within the next 60 to 90 days so that the Superintendent of Public Works can have them installed during the wet part of the winter when it will be impossible to do any road work.

PAVING OF MAGDALENA & BRIDLE PATH Report of Councilman Blakelock regarding responsibility for paving Magdalena Avenue and the Bridle Path east of Cordoba Avenue, as requested by property owners. The City Attorney informed the Council that; if the streets are maintained in a dangerous and unsafe condition there might be a liability on the part of the City for damages occurring as a result thereof to one using such streets; that there is no requirement for the City to pave or surface any street or to keep it in passable condition. However, if the maintenance of any street is assumed by the City, its only obligation would be to keep the same in a reasonably safe condition as the circumstances and funds of the City permit. In other words, there is no obligation on the part of the City to repair, surface or otherwise maintain streets, but there is a liability if the maintenance of streets is assumed and they are allowed to become dangerous and damages result to a person using same, when the City does have funds with which to repair or otherwise alleviate such dangerous conditions.

With respect to the matter of the Bridle Path east of Cordoba, it was pointed out that the City did not own the Bridle Path; that it was vested in the name of the Bank of America; and that it would be a matter for the individual desiring to have the Bridle Path paved to acquire an easement from the owners of the property, and do the paving at his own expense.

The Mayor requested the City Attorney to advise the owners of the property fronting Magdalena what the City's position is in the matter.

Councilman Blakelock recommended that the City Clerk advise Mr. Tepper that the City had no right to enter upon the Bridle Path for improvements as it was private property.

FEES FOR USE OF CLUB HOUSE

Report of Councilman Blakelock and Councilman Hempel regarding fees for the use of the Community Club House. Mr. Blakelock stated that he and Mr. Hempel had studied the situation and made the following recommendations:

That the regular charges of \$6.00, \$9.00 and \$12.00, and \$60.00 for dances, as set forth in the original recommendation, be made to organizations which are regular users of the Club House on regular meeting nights, and that such charges will apply to their regular dates.

IT WAS MOVED BY COUNCILMAN BLAKELOCK SECONDED BY COUNCILMAN CARRICK that the rates at the Community Club House be established at \$6.00, \$9.00 and \$12.00 for regularly scheduled meetings, and at \$60.00 for

IT WAS MOVED BY COUNCILMAN HEMPEL, SECONDED BY COUNCILMAN BLAKELOCK AND UNANIMOUSLY CARRIED that the above rates apply only to local organizations and that all others must secure permission for the use of the Club House from the City Council, at which time rates will be fixed.

JOB COSTS OF INSTALLA-TION OF WATER METERS

Councilman Carrick reported that a survey had been made of job costs in connection with the installation of water meters, and it was determined that the average costs are 3/4" water meters - \$59.92, and 1" water meters - \$96.13.

Mr. Carrick recommended that the \$50.00 charge for a 3/4" meter be increased to \$75.00; that the 1" meter be increased to \$110.00; and that meters of $1\frac{1}{2}$ " or larger be installed on a cost plus 10% basis with a deposit required for the estimated cost of the installation.

Councilman Hempel recommended a reduction to \$65.00 for 3/4" meters and \$100.00 for 1" meters.

AMENDMENT TO ORDINANCE NO. 163

UPON MOTION OF COUNCILMAN CARRICK SECONDED BY COUNCILMAN BLAKELOCK the City Attorney was directed to prepare an amendment to Ordinance No. 163 covering the changes recommended by Mr. Carrick.

INCREASE OF WATER RATES FOR TRAILER PARK

Councilman Carrick moved that the water rates for the Trailer Park located north of the City limits, be doubled, as the Trailer Park is paying neither. City taxes nor a business license.

Councilman Hempel stated that some increase was probably justified and recommended that a 50% increase be made.

Following discussion Councilman Carrick . amended his motion to agree with Mr. Hempel's recommendation. THE MOTION WAS SECONDED BY COUNCILMAN FORTUNE.

GEOLOGICAL & SEISMOGRAPHIC

Councilman Carrick reported on the matter of authorizing execution of an agreement with STUDY OF WATER Loren Blakeley and associates of Orange, SUPPLY BY California for the purpose of their conducting LOREN BLAKELEY a geological and seismographic study of the water bearing formations in connection with the San Clemente water system and requesting from Mr. Blakeley, positive answers to the following questions:

- What is the source of our present water supply?
- 2. Where does the water enter the present water bearing formation?
- What is the extent of our present water-bearing formation? Furnish maps showing this information.
- What is the maximum safe yield of our water-bearing formation - per day, per month?
- 5. Is our water-bearing formation connected to the ocean, and what are the possibilities of salt water intrusion?
- Where should the next two wells be drilled, 6. and to what depth to furnish 600 gallons per minute, each?

Mr. Hempel inquired if Mr. Blakeley's fees were comparable to other proposals submitted. Mr. Carrick stated that Mr. Blakeley's fees were lower.

There was some discussion as to whether or not Mr. Blakeley would agree to furnish answers to all the questions outlined by Mr. Carrick, and the City Attorney recommended that Mr. Blakeley submit a form of contract for his information, which could be put in legal form for execution by the City of San Clemente.

IT WAS MOVED BY COUNCILMAN CARRICK SECONDED BY COUNCILMAN HEMPEL that the City Attorney be directed to prepare a form of contract between the City of San Clemente and Mr. Blakeley, and that the Mayor and the City Clerk be authorized to sign same on behalf of the City.

RESOLUTION OF APPRECIATION TO TENT CAMP 3 OFFICERS

Councilman Carrick recommended that a Resolution of Appreciation be drawn up and sent to the Commanding Officers of Tent Camp 3, at Camp Pendleton, expressing the thanks of the City Council and Officials for the courtesies extended them on their recent tour of the camp. The matter was referred to Resolutions (see Resolution No. 587).

Councilman Carrick reported that efforts had been made to sell the sludge at the sewage disposal plant, but that to date all efforts were unsuccessful.

IT WAS MOVED BY COUNCILMAN CARRICK SECONDED BY COUNCILMAN BLAKELOCK AND UNANIMOUSLY CARRIED that the sludge at the sewage disposal plant be given away to anyone interested provided it is removed from the drying beds.

Councilman Carrick reported that the cabanas located on capital company property at the beach are in a state of disrepair.

REQUEST FOR REPAIR ON CABANAS

IT WAS MOVED BY COUNCILMAN CARRICK SECONDED BY COUNCILMAN FORTUNE THAT a letter be directed to Mr. Stan Herring, owner of the cabanas, requesting that repair work be undertaken to alleviate the situation.

TRUCK EXHAUST PIPES

EFFORTS TO Recommendation of Mr. Carrick that the REDUCE NOISES Commissioner of the California Highway Patrol conduct ALONG HIGHWAY a survey of excessive noise caused by truck exhaust MADE BY pipes along the Highway.

Mr. Carrick recommended that a letter be sent to Mr. Clifford E. Peterson, Commissioner of the California Highway Patrol, requesting that a survey be conducted in the City of the excessive noise caused by truck exhaust pipes, and that a crusade to reduce the noise be launched.

IT WAS MOVED BY COUNCILMAN CARRICK, SECONDED BY COUNCILMAN HEMPEL AND UNANIMOUSLY CARRIED that the City Clerk write such a letter.

BIDS ON TRANSITE PIPE

Report of Councilman Carrick concerning the call for bids on Transite Pipe, held over from the last regular meeting, and recommending that the bid of Johns-Manville Corporation for 1.477¢ per linear foot be accepted and awarded, was read.

ACCEPTANCE OF JOHNS-MANVILLE BID ON TRANSITE PIPE

WATER BOND ISSUE Report of the Mayor regarding status of agreement with the Currie Engineering Company. Mayor Read recommended that the City Council meet representatives of the Currie Engineering Company within the next week or two to work out a form of agreement for the work in connection with the proposed Water Bond Issue, and to determine what work, as outlined in the original contract, should be completed, and the amount of payment due Mr. Currie.

The Mayor recommended that the City Attorney and Mr. Currie confer on the form of contract to be drawn for services rendered in connection with the Water Bond Issue.

The problem of enforcing the Dog License Ordinance was discussed and the Chief of Police stated that with his present manpower it was virtually impossible to police the City.
