Pursuant to ORDINANCE No. 202 an adjourned regular meeting of the City Council of the City of San Clemente held in the Council Chamber, City Hall, 408 No. El Camino Real, San Clemente, California, Tuesday, January 15, 1952 at 8:00 o'clock P.M. to canvass the returns of the Special Bond Election held Tuesday, January 8, 1952, Mayor H. T. Read in the Chair.

On roll call the following were -

This being the time and place fixed by law for the City Council to open and canvass the absentee ballots of the Special Bond Election held Tuesday, January 8, 1952 and to canvass returns of Election Precincts A and B as set forth in Resolution No. 542, hereinafter written and made a part of these minutes:

RESOLUTION NO. 542

RESOLUTION OF THE CITY COUNCIL OF
 THE CITY OF SAN CLEMENTE, CALIFORNIA
 STATING THE RESULT OF THE CANVASS OF
 ELECTION RETURNS OF THE SPECIAL BOND
 ELECTION HELD JANUARY 8, 1952.

WHEREAS, the City Council of the City of San Clemente, California, by Ordinance No. 202, duly called and provided for the holding of a special election in said City on January 8, 1952, for the purpose of submitting to the qualified voters of said City the following proposition, to wit:

"BOND PROPOSITION: Shall the City of San Clemente incur a bonded indebtedness in the principal sum of \$427,000 for the purpose of the acquisition and construction by said city of a certain municipal improvement, to wit: Additions to and improvements of the water system of said City consisting of additional water wells, a reservoir and booster station, the replacement (including relocation where necessary) of existing water lines, and the installation of additional water lines, including the acquisition of all land, easements, pipe, valves, pumps, fittings, appurtenances and other property necessary therefor?"

; and

WHEREAS, notice of said election was duly and regularly given in time, form and manner as provided by law, and said election was on said

date duly held at the polling places referred to in said ordinance, and the votes cast thereat were canvassed and the returns thereof made at the time and in the manner and form provided by law; and

WHEREAS, on this 15th day of January, 1952, said City Council has duly assembled at its usual place of meeting and has canvassed the returns of said election;

NOW, THEREFORE, the City Council of the City of San Clemente, California, DOES HEREBY RESOLVE AND DETERMINE as follows:

Section 1. That from said returns it appears, and this City finds, that the total number of votes cast in each of the respective election precincts established for said election upon said proposition, and for and against said proposition, the total number of absentee votes cast at said election upon said proposition and for and against said proposition, and the total number of votes cast in said city upon said proposition and for and against said proposition, are as follows:
