CONFERENCE ON STREET AND HICHWAY **PROBLEMS** 

Letter from the University of California announcing a Conference on Street and Highway Problems, was read. The Mayor recommended that the Chief of Police and the Mayor be authorized to attend this Conference.

Upon motion of Councilman Hempel, seconded by Councilman Fortune, the Chief of Police, Mr. Arthur Daneri and Mayor H. T. Read were authorized to attend the California Conference on Street and Highway Problems at the University of California in Los Angeles, February 6 to 8, 1952.

The motion was unanimously carried.

TRAFFIC SIGNALS

Letter from Dudley Hamilton regarding installation of Traffic Signals and Safety Signs, was read. The Mayor stated he would write a letter to the State of California, Division of Highways, recommending that the suggestions in Mr. Hamilton's letter with regard to providing warning signs along the curves between El Portel and Florencia Avenues on Highway 101, be considered.

THURSDAY MORN-ING GARDEN CLUB

Letter from the Thursday Morning Carden Club acknowledging the City Council's commendation for their tree-planting project on Avenida Esplanade, was read and ordered filed.

SPECIAL CENSUS

Letter from the Department of Commerce, Bureau of Census regarding à Special Census, was read and the City Attorney stated that the City of San Clemente was limited too two censuses in the ten year period between government censuses, and recommended that the League of California Cities be contacted for their advice as to the best possible time for a special census. The Mayor directed that such a letter be written.

OFFER OF SCHOOL DIST. TO SELL LOT 61, BLOCK 4, TRACT 794

Letter to the City Council from the San Clemente School District offering for sale Lot 61, Block 4, Tract 794 for the sum of \$700, was read and referred to "Resolutions".

D. HAMILTON RE-QUEST THAT AUDIT RECEIPTS AND DISBURSEMENTS

Letter from Dudley Hamilton requesting that an audit be made of the City's receipts and disbursements for the past seven years, was read. Councilman Campbell informed BE MADE OF CITY'S Mr. Hamilton that the City's books were audited regularly by a Certified Public Accountant, and that if any interested person desired to have an audit made at his own expense, the City would be ready and willing to make its records available. The City Attorney informed Mr. Hamilton that the firm auditing the City's books is probably the finest auditing firm in Southern California, having many of the cities in Orange and Riverside Counties as Clients.

ORAL COMMUNICA-TIONS

Mr. Green of the Standard Oil Company of California addressed the City Council stating that he regretted his Company was unable to participate in the call for gasoline bids due to the fact that gasoline reserves were being taken by the armed forces.

UNFINISHED

The matter of purchasing Lot 25, Block 2, Tract 779 from George J. Beauchamp, was considered. The Council felt that the asking price of \$2,500 by Mr. Beauchamp was excessive. .Mr. Hempel suggested that a trade be made for a lot of equal value, which would possibly be good business on the City's part.

LOT 25, BLK. 2 TRACT 779 -BEAUCHAMP

> It was moved by Councilman Hempel, seconded by Councilman Blakelock and unanimously carried, that the City Clerk be directed to correspond with Mr. Beauchamp advising him that the asking price of \$2,500 was found to be unacceptable to the City Council and suggesting that a trade might be negotiated whereby Mr. Beauchamp would receive a lot of equal value to his own.

BALANCE DUE ON TAX SALE LOTS - TONY ORTIZ The matter of granting an extension of time for payment of the balance due on tax sale lots to Mr. Tony Ortiz, was considered. The Clerk was directed to advise Mr. Ortiz of the expiration of extension granted, and report the progress of this negotiation at the next regular meeting, at which time the Council will take further

CONVERTING REST ROOMS TO SHOWER ROOMS The matter of converting the rest rooms at the Pier to shower rooms was ordered referred to a Committee composed of Councilman Campbell and Superintendent of Public Works Parker, to investigate this matter more fully and make recommendations for a course of action at the next regular meeting.

SPECIAL COM-MITTEES AND OFFICIALS The Clerk reported he had received a request for payment of membership dues for 1952 from the Orange County Coast Association. After discussion, it was moved by Councilman Hempel, seconded by Councilman Fortune and unanimously carried that the payment be rejected.

PERSONNEL PRO-CEDURE Report of the Committee on Personnel Procedure was read and discussed at length by the City Council. Several minor changes were recommended by the City Attorney and Councilman Blakelock. It was moved by Councilman Blakelock seconded by Councilman Campbell and unanimously carried that acceptance of the proposed plan be held open and the suggested changes made and re-submitted at the next regular meeting.

STORM DRAIN GRATES

Report of Superintendent of Public Works Parker regarding the installation of storm drain grates. Mr. Parker reported that he had received the price of \$80.00 each for the large size and \$50.00 each for the smaller size, and recommended that, in cases where the City is forced to excavate at the curb line to replace or repair damage caused by the recent rains, consideration be given to redesigning the catch basin. Mr. Hempel recommended that the City start a replacing program to extend over several years, repairing possibly ten of the most needed drains this year. The Mayor instructed the Commissioner of Streets, Mr. Blakelock, to work with Mr. Parker on a survey of the storm drains to determine which drains present the worst hazard, and to report at the next regular meeting.

AIR COMPRESSOR

Mr. Parker recommended that the Council consider the purchase of a new air compressor to replace the one currently in use by the City. He stated that this compressor had become badly worn and required a great amount of maintenance, having reached the point where it would no longer do the job required. After discussion, it was moved by Councilman Blakelock, seconded by Councilman Hempel and unanimously carried, that the City call for bids for the purchase of one No. 105 C.F.M. Air Compressor, at the meeting to be held February 20, 1952.
