1. SPECIAL PRESENTATIONS

A. Plaza San Clemente Project Update

Steve Craig narrated a PowerPoint presentation entitled "Outlets at San Clemente", which summarized the status of the Marblehead Coastal commercial project; responded to Council inquiries. A hard copy of Mr. Craig's PowerPoint is on file with the City Clerk.

In response to Council inquiry, Mr. Craig indicated that he is ready to discuss having an Orange County Sheriff Department presence at the project.

Council requested copies of Mr. Craig's PowerPoint.

B. New Principal of San Clemente High School - Michael Halt

Michael Halt, the new principal of San Clemente High School, reviewed the school's academic, sports and art programs.

C. San Clemente High School Report

Matt Garritson and Gabby Meyer, student representatives of San Clemente High School, narrated a PowerPoint presentation entitled "San Clemente High School", that summarized campus activities. A hard copy of the subject PowerPoint is on file with the City Clerk.

D. State Drought and San Clemente Water Conservation Programs

Andrew Kanzler, the City's Water Conservation Analyst, narrated a PowerPoint presentation entitled "State Drought and San Clemente Water Conservation Programs"; responded to Council inquiries. A hard copy of Mr. Kanzler's PowerPoint, dated February 18, 2014, is on file with the City Clerk.

2. ORAL COMMUNICATIONS (PART 1)

Substance Abuse

<u>Susan Parmelee</u>, on behalf of the San Clemente Collaborative, provided an update on Collaborative accomplishments, noting that two health forums were held last year in addition to the Wellness and Prevention Program that took place at San Clemente High School; noted that the Collaborative supports the Save Our Students Club (SOS) at San Clemente High School; stated that the Collaborative's meeting on February 20, 2014 will focus on volunteerism.

Sophia Spralja, San Clemente, explained that she is the founder and president of the Save Our Students Club (SOS) at San Clemente High School; explained that the Club's goals are to provide healthy activities for teens, help students with drug and alcohol problems, and to promote a culture that drug usage is not the norm; requested that the City support the Club by providing venues for its events.

Council requested that Ms. Spralja contact Mayor Brown and City Manager Gudgeirsson to discuss her request.

<u>Pondo Vleisides</u>, San Clemente, voiced concern that some members of the community are struggling with addictions; expressed a desire to work with the City and the San Clemente Collaborative to address addiction problems; suggested that the City work with community resources to make a difference.

Marblehead Coastal Commercial Development Signage Program

Richard Boyer, President of San Clemente Citizens for Integrity in Development, stated that Council previously approved 32 freeway-facing signs for the Marblehead Coastal commercial project; reviewed that his organization filed a lawsuit that resulted in the court ordering the City to cancel the Sign Exception Permit; displayed view simulations of the project that were posted to the City's website, pointing out that no signs were visible.

Council requested that the City Manager ascertain, and inform Council, of the developer's signage plan for the Marblehead Coastal commercial development.

A. FY 2014 2nd Quarter Report and Mid-Year Budget Adjustments

Report from the Assistant City Manager concerning the FY 2014 2nd Quarter Report and mid-year budget adjustments.

Assistant City Manager Sund provided introductory comments.

Finance Manager Vincent narrated a PowerPoint presentation entitled "FY 2014 Mid-Year Financial Report as of December 31, 2013"; responded to Council inquiries. A hard copy of Ms. Vincent's PowerPoint is on file with the City Clerk.

During the ensuing discussion, Council requested that the library be included in future CIP reports and that the status of the Courtney's Sandcastle project be accurately reflected, instead of being referenced as "on time".

In response to Council inquiry, Lt. Coppock reported that the crime statistics in the 2nd Quarter Report are inaccurate, noting that Part 1 crimes (i.e., major crimes such as murder, rape, and robbery) actually decreased 1% in calendar year 2013.

MOTION BY COUNCILMEMBER BAKER, SECOND BY COUNCILMEMBER EVERT, CARRIED 5-0, to:

- 1. Approve the FY 2014 2nd Quarter Report.
- 2. Approve and authorize the mid-year adjustments listed in "Attachment A" of the Administrative Report, dated February 18, 2014, that is on file with the City Clerk.

MEETING RECESSED

Council recessed at 7:50 p.m. and reconvened at 8:03 p.m., with all members present.

B. <u>Contract Amendment - Crossing Guards at Avenida Calafia/Avenida</u> Del Presidente and Avenida Talega/Calle Portofino

Report from the Public Works Director/City Engineer concerning the possibility of amending the City's contract with All City Management Services to enhance school crossing guard services.

Transportation Engineering Manager Frank narrated a PowerPoint presentation entitled "Contract Amendment - Crossing Guards at Avenida Calafia/Avenida Del Presidente and Avenida Talega/Calle Portofino" and responded to Council inquiries. A hard copy of Mr. Frank's PowerPoint, dated February 18, 2014, is on file with the City Clerk.

<u>Dallas Bellantonio</u>, San Clemente, stated that her children attend Concordia Elementary; noted that approximately 100 of Concordia's 700 students walk or ride their bicycles to school; opined that a crossing guard is needed.

<u>Juliane McGuire</u>, San Clemente, stated that traffic has increased on Avenida Presidente; voiced concern that Concordia Elementary and Lobo Elementary are the only San Clemente schools that do not have a crossing guard.

Brenda Miller, San Clemente, urged that Council authorize the additional crossing guards; suggested that the effectiveness of the crossing guards could be measured by the number of parents who are comfortable allowing their children to walk or ride their bicycles to school; pointed out that four vehicle trips are avoided for each child who travels to school by walking or riding a bicycle; stated that engineering modifications represent a desirable permanent solution and urged that the City apply for an OCTA grant to fund engineering studies and a professionally operated bicycle train to school.

MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER BAKER, CARRIED 5-0, to:

1. Approve, and authorize the Mayor to execute, Amendment No. 1 to Contract No. C06-40, by and between the City of San Clemente and All City Management Services, providing for a crossing guard at Avenida Calafia/Avenida Del Presidente, and an additional crossing guard at Avenida Talega/Calle Portofino, for an additional cost of \$8,600.

- Approve a transfer of \$8,600 from the City Council Contingency to Account 001-218-43624-000-00000.
- 3. Concur with the Planning Commission that the crossing guards are a temporary measure until a permanent solution to the traffic problems at the intersections can be addressed.

Council requested to be informed about the effectiveness of the crossing guards.

C. <u>Doheny Desalination Project</u>

Report from the Public Works Director/City Engineer concerning the Doheny Desalination Project.

Assistant City Engineer Rebensdorf narrated a PowerPoint presentation entitled "Doheny Desalination Project" and responded to Council inquiries. A hard copy of Mr. Rebensdorf's PowerPoint, dated February 18, 2014, is on file with the City Clerk.

<u>Susan Hinman</u>, Metropolitan Water District of Orange County (MWDOC), expressed concern about San Clemente's water availability because the city is located at the end of the two water pipelines; pointed out that 95% of San Clemente's drinking water is imported; urged the City to invest in a reliable and diversified water supply.

MOTION BY COUNCILMEMBER BAKER, SECOND BY MAYOR PRO TEM HAMM, CARRIED 5-0, to direct Council's representative on the Doheny Desalination project and Staff to continue involvement in the project, but not provide grant match funding for the Metropolitan Water District's Foundational Action Plan.

D. Conceptual Design for Restriping on Avenida Vaquero

Report from the Public Works Director/City Engineer concerning the conceptual design for restriping on Avenida Vaquero.

Transportation Engineering Manager Frank narrated a PowerPoint presentation entitled "Approval of a Conceptual Design for the Restriping of Avenida Vaquero" and responded to Council inquiries. A hard copy of Mr. Frank's PowerPoint, dated February 18, 2014, is on file with the City Clerk.

Michael Johnson, San Clemente, conveyed the importance of retaining parking on the east side (slope side) of Avenida Vaquero because parking on the west side is limited; stated that people use the center lane.

Tom Marier, speaking on behalf of AMMCOR (the managing agent for The Coast Homeowners Association) as well as himself, pointed out that Avenida Vaquero already has a bicycle lane; questioned why the City is considering devoting 28% of the roadway to bicycle lanes when bicycle traffic represents less than 5% of roadway users; conveyed his opinion that deleting the center turn lane will not slow traffic; conveyed his preference that the striping on Avenida Vaquero be left in its current configuration, or at the very least, that Council approve Option D.

Angela Holland, San Clemente, commented that the current striping on Avenida Vaquero is effective and safe and should not be changed; noted that pedestrians utilize the center lane as a crossing safety zone; recommended that Council allow Avenida Vaquero to remain in its current state, or approve Option D as an alternative; presented a CD that demonstrates Avenida Vaquero's current conditions.

<u>Richard Boyer</u>, San Clemente, stated that the current bicycle lane is inadequate and expressed support for Option B; stated that much praise has been given to the striping changes on Avenida de los Mares and that people would like for the same striping to be continued along Avenida Vaquero; recommended that sharrows be installed on the western side of Avenida de los Mares from Avenida Vaquero to the Ralphs Ocean View shopping center.

Michael Metcalf, San Clemente, stated that Avenida Vaquero is a major thoroughfare and opined that more space needs to be allocated to bicycles and pedestrians; urged Council to approve Option B since his preferred configuration (Option A) does not appear to have popular support.

<u>Pete van Nuys.</u> Orange County Bicycle Coalition, urged Council to approve Option B; noted the importance of slowing traffic for safety reasons.

Robert Regan, San Clemente, stated that Avenida Vaquero does not have an accident history; suggested that more traffic enforcement is needed.

George Allen. San Clemente, complimented the roadway configuration of Camino de los Mares; urged that the center lane on Avenida Vaquero be deleted and that bicyclists be allocated 8' of the roadway.

Brenda Miller, San Clemente, noted that Avenida Vaquero is an important bicycle transportation corridor; stated that bicyclists need at least 4' to clear a door that is opening from a parked car, so that they are not forced into a vehicle travel lane; spoke in support of Option B, noting that the bicycle lane will allow parents and their children to ride their bicycles side by side and will also enable bicyclists to carry a surfboard; stated that Option B will also allow residents of Avenida Vaquero a greater line of sight as they exit their driveways because vehicles will be located in the center of the street; recommended that Council give complete streets a chance.

<u>Jamie Bixler</u>, San Clemente, opined that Avenida Vaquero does not need striping changes; noted that she periodically relies on the center lane when pulling out of her driveway.

Mark McGuire, on behalf of the Shorecliffs Golf Course, acknowledged that Avenida Vaquero is an important bicycle corridor; suggested a hybrid option that would allow left-turn lanes at major intersections (including left-turn lanes into the Shorecliffs Golf Course and San Gorgonio Park); noted that there are areas on Avenida Vaquero where parking is not needed; voiced concern that a wide bicycle lane could be misconstrued as a vehicle lane.

Following discussion, MOTION BY MAYOR BROWN, SECOND BY COUNCILMEMBER EVERT, CARRIED 3-2 (COUNCILMEMBERS BAKER AND DONCHAK VOTING NOE), to approve the conceptual design for restriping Avenida Vaquero as shown on Option B, as contained in the Administrative Report, dated February 18, 2014, which is on file with the City Clerk, with additional direction to Staff to include left-turn lanes at intersections, where appropriate. Staff is to inform Council of the intersections at which left-turn lanes will be provided.

Mayor Pro Tem Hamm reported on his visit to the City's skate park, noting that some second graders at Concordia Elementary School are heading an effort to encourage youth to wear helmets while skateboarding.
