AGREEMENT FOR EXPENDITURE OF ½¢ STATE GAS TAX MONEY FOR STREETS OF MAJOR IMPORTANCE. PROJECT NO. 9.

Communication from S. V. Cortelyou, District Engineer, Division of Highways, District VII, Los Angeles, enclosing Memorandum of Agreement, in triplicate, for expenditure of $\frac{1}{4}\phi$ State Gas Tax money for streets of major importance in City for fiscal year 1945, also copy of Resolution required for Project No. 9; was read and referred to "RESOLUTIONS."

ORAL' COMMUNICATIONS.

Tom Murphine, President of the Peace Officers Association, and Cuba Morris, member of the California Highway Patrol, appeared before the Council and explained the working of the proposed Curfew Ordinance and both strongly stressed the need for a uniform Curfew Law throughout Orange County. They also stated the County of Orange and six other cities had adopted the Ordinance or were in the process of doing so, but that in order to make it work satisfactorily it would be necessary for all communities to adopt it.

While all Councilmen agreed in an Ordinance of this nature, they thought the present proposed Ordinance was just a little

tough and required modification.

After quite a length discussion it was decided to hold same over for further discussion at next meeting.

REPORTS OF SPECIAL COMMITTEES.

Councilman Preston, Commissioner of Water, reported that last Wednesday he had taken a trip to San Mateo Creek_along with Mayor Strang, City Engineer William A. Ayer and James Henry Bennett, Superintendent of Public Works.

They had practically decided on a site for well location and had instructed William A. Ayer, City Engineer, to make a survey and plat and get blueprints showing what territory we will travel over. In order to complete plan will plot right up to the proposed reservoir which, if ground is available, would be alongside one we have now. We would have to get in would be alongside one we have now. We would have to ge touch with the Officer in Charge at Camp Pendleton as the application will have to go through him and get him to give us his friendly word. Then we would have to contact our Senator and Congress representatives so that after the war is over we will be able to go ahead with our long needed extra reservoir and new well.

UNFINISHED BUSINESS.

BUILDING ORDIN-ANCE TO BE AMENDED TO READ 800 SQUARE FEET INSTEAD OF 600 SQUARE FEET.

Mayor Strang brought up the matter of revamping our present Building Ordinance requiring 800 square feet instead of the present 600 square feet for residential buildings.

Councilman Preston said 600 square feet was too much in the

nature of a shack.

After a slight discussion City Attorney McKinney was authorized and instructed to draw up necessary changes to cover the entire city with the exception of Tracts 823 and 899 in the Industrial District.

\$125.00 PER MONTH.

Vouncilman Sturgis reported about a week ago he interviewed George Schlotterbeck regarding position in Police G.I.SCHLOTTER-Departments Office, and he appeared to be interested. He told him he would pay him \$4.00 per day till next Council meeting. To Police DEPT: Schlotterbeck informed him he would take the job at \$125.00 per month. He would like to know if this met with the approval of the Council.

Having received Council's approval, it was Moved by Councilman Smith, seconded by Councilman Preston, that we hire George I. Schlotterbeck on the Police Department at a

salary of \$125.00 per month.

A Notice would be inserted in the San Clemente Sun to this effect so that all dog owners could see and so keep their dogs under control. During the hot weather sometimes an otherwise quiet dog might necome vicious and even infected with rabies.

LICENSE GRANTED FOR SANDWICH SHOP 106 S. EL CAMINO REAL.

The request of Mrs. Ada Mae Benton and Mrs Edith Lovell for a License to operate a Cafe, to be known as the El Camino Sandwich Shop, located at 106 S. El Camino Real, was considered and the request granted Clark height instructed to issue the and the request granted. Clerk being instructed to issue the necessary License.

Councilman Preston again brought up the matter of what could be done to alleviate the squirrel question as they were doing considerable damage.

James H. Bennett, Superintendent of Public Works, said he had a quantity of poison but did not not have labor enough to put on a campaign against the pests. Any citizen wishing to do this work himself would be supplied with the poison free of charge upon tequest.

NEW SEWER EQUIPMENT REQUIRED.

Mr. James H. Bennett, Superintendent of Public Works, informed the Council he was badly in need of some new sewer equipment to take care of the present situation. 1800' feet of the sewer from the toilets at the beach to the sewer pump was choked and the rest rooms were flooded, and the only thing was to buy some more equipment. He said itewouldscost \$540.00 to clean out that much pipe by contract.
