The Minutes of the last regular meeting of the City Council held Wednesday October 4th, 1944, were read and approved as read.

Communication from Ralph E. Swing reminding of the meeting COMMUNICATION. of the sub-committee on Post War Construction which will be held Tuesday October 17th, 1944 at 10:00 a.m. at the Court House, Santa Ana and asking that we have an advance copy of the proposed projects in order they may be arranged in order desired.

(Mayor Strang attended thismeeting and advanced the following proposals: - Improvements - Outfall Sewer Sewer Lines - South end of Town 10,000.00 50,000.00 115,000.00 175,000.00 Water Works and Wells

submitted to Senate Committee October 17th, 1944) Communication ordered filed.

Communication from Major General Chas. F.B. Price, Office of the Commanding General, Fleet Marine Force, San Diego Area, Marine Corps Base, San Diego 40, California, advising our letter together with enclosures pentaining to water system had been received and forwarded to Washington for consideration, also that favorable action has been recommended, and enclosing us a copy of his forwarding endorsement. Same ordered filed.

Communication from the Department of Commerce, Bureau of the Census, Washington stating they hoped to commence the San Clemente Census some time in November; was read and ordered filed.

Mayor Strang said he and Councilman Preston attended the Senate Interim Committee on postwar work yesterday in Santa Ana.

He said the Committee members were trying to find out what the local problems will be in Orange County in the post:war period.

Representatives of several cities described their local problems and what projects they had planned to help alleviate the

expected surplus of labor as well as constructing much needed improvements.

Post-War work It was proposed that the State allocate funds for post-war Santa Ana, Oct.work if cities were unable to stand the total cost of new improvements - funds had already been allocated to various communities but money for actual construction can not be appropriated until the next meeting of the State Legislature in January 1945.

Mayor Strang presented as the post-war projects of the City a New Source of Water Supply, new water reservoir and lines, also improvements in the present sewer system, also there is a possibility

that resurfacing or improving the city's streets may be added.

Mayor Strang pointed out to the Committee that a small community could not compete with the larger cities in matching state funds, and suggested that a plan be worked out whereby cities of small population have a minimum base of allocated fundsbefore the population of said cities is taken into consideration. He stated that San Clemente has almost as many miles of streets as Santa Ana, but with its small population, does not receive a fraction of the State allocation that Santa Ana gets. We must keep our eyes and ears open and if any money is being distributed we want to be on our toes. and got it.

ILLUMINATED SIGN AT INTER# SECTION OF DEL MAR POINTING OUT PIER AND BEACH.

Councilman Preston brought up the question of an Archway across Del Mar as suggested by Councilman Smith some time ago. This is to be in the nature of a direction sigh at the intersection stressing the Pier and Fishing.

Mayor Strang appointed Councilman Smith and Council-

man Preston as a Committee to work out plans after those proposed by the San Clemente Chamber of Commerce some time ago. They called for a high post standard to be erected over the traffic button at the intersection with a Neon Sigh in the shape of a Fish pointing in the direction of the Beach and also carrying a sigh as "San Clemente Beach and Pier".

Councilman Preston said the cost of such asign would not be prohibitive and would certainly be a great asset in letting visitors know that San Clemente possessed a wonderful beach and pier.

A Plan to point and erect new street markers, to be sponsored by the Womens Club was given the approval of the Council. The Club will furnish the paint and have the lettering done but the Council were asked to provide the posts. It is proposed to start the work at once.
