REQUEST FOR PERMISSION TO BUILD FENCE AND WALL

LETTER FROM CHARLES D. PIAS requesting permission to encroach upon certain sections of City property by erecting a stake fence and masonry wall, was read and referred to Resolutions (See Resolution No. 586).

ORANGE COUNTY

LETTER FROM THE CITY OF FULLERTON re-TEL. DIRECTORY garding a proposal of the Pacific Telephone and Telegraph Company to divide the classified section of the Orange County telephone directory into three sections, was read.

> The City Attorney advised the Council that the Chamber of Commerce and the businessmen of the City should be vitally interested in this, but that the City Council should take no action.

Councilman Blakelock recommended that we thank the City of Fullerton for calling the matter to our attention, and refer it to the Chamber of Commerce for their attention; whereupon the Mayor ordered a letter of acknowledgment to be written to the City of Fullerton and the matter referred to the Chamber of Commerce for any action they may wish to take.

HOUSE TRAILERS

LETTER FROM REEVES RUBBER COMPANY, INC. concerning temporary facilities for the place-ment of 15 house-trailers near their plant, was read.

The City Attorney pointed out that this letter was a letter of inquiry and not a formal application for a trailer park permit, and recommended that Reeves Rubber Company be advised that before permission can be given for the placement of house-trailers near their plant, a formal application must be submitted in conformity with the Trailer Park Ordinance. This would be read at one Council meeting and held over for a second reading at the following Council meeting at which time pros and cons could be heard and a decision made by the Council.

IT WAS MOVED BY COUNCILMAN BLAKELOCK that the City Clerk address a letter to the Reeves Rubber Company in answer to their letter stating that their request for a permit to establish a trailer camp on their property would be approved by the Council provided requirements of the City Ordinance are met.

Mr. Carrick stated that he would second the motion if any permit issued is a temporary one. It was pointed out that if Dr. Reeves complied with the City requirements the permit could not be a temporary one.

The City Attorney recommended that Councilman Blakelock's motion be changed to request the City Clerk to advise Dr. Reeves of what the present requirements of the City are and the procedure to be followed in making a formal application for a trailer park permit, and to further advise him that it would be impossible to issue a temporary permit due to State trailer park requirements.

COUNCILMAN BLAKELOCK AND COUNCILMAN CARRICK agreed to the change as recommended by the City Attorney AND THE MOTION WAS UNANIMOUSLY CARRIED.

CLEARANCE OF WEEDS, ETC.

LETTER FROM J. C. SETZER AND OTHERS regarding the clearance of weeds and the obstruction of views caused by growth of trees, was read and referred to Councilman Blakelock and Superintendent of Public Works, Parker, for their consideration and recommendation.

TRAILER PARKS

LETTER FROM THE SAN CLEMENTE BOARD OF REALTORS with respect to restrictions governing Trailer Parks, was read and ordered filed.

SALE OF TAX DELINQUENT PROPERTY LETTER FROM THE COUNTY OF ORANGE, regarding sale of tax delinquent property described as Lot 54, Block 13, Tract No. 793, was read.

UPON MOTION OF COUNCILMAN FORTUNE SECONDED BY COUNCILMAN HEMPEL the City Clerk was instructed to advise the County of Orange that the City of San Clemente did not object to the sale of Lot 54, Block 13, Tract 793.

1% SALES TAX

LETTER FROM THE LEAGUE OF CALIFORNIA CITIES advising that the Los Angeles County Board of Supervisors had requested that a 1% sales tax be levied on business in the unincorporated and urban areas, was read.

The original proposal by the California Supervisors' Association was to collect a State-wide 4% sales tax which would permit the Counties to collect a 1% sales tax in the urban and unincorporated areas, 1/4% within the incorporated cities and the remaining 3/4% within the incorporated cities to be returned to the cities for their use.

Councilman Blakelock stated that the matter would be discussed at the League of California Cities' Convention to be held in San Diego in October, and recommended that the City of San Clemente go on record as opposing the original proposal of the California Supervisors' Association which would give them 1/4% sales tax to be collected within the incorporated areas of cities.

IT WAS MOVED BY COUNCILMAN BLAKELOCK SECONDED BY COUNCILMAN CARRICK AND UNANIMOUSLY CARRIED that the City representatives attended the League of California Cities' meeting to be held in San Diego in October, be instructed to advise the League representatives that the City of San Clemente opposes the original proposition of the California Supervisors' Association to impose a Statewide uniform 4% Sales Tax and collect a portion thereof within incorporated cities.

MEDICAL SUPPLIES'

ES' LETTER AND RESOLUTION FROM THE COUNTY OF ORANGE, OFFICE OF CIVIL DEFENSE AND DISASTER RELIEF CONTROL concerning medical and hospital supplies' warehouse in Tustin, was read and referred to Resolutions (see Resolution No. 582).

FLOOD CONTROL LETTER FROM P. R. GREGORI OF THE GREGORIAN COPPER COMPANY expressing his thanks for the efforts of the City Council in getting the Flood Control project under way, was read and ordered filed.

THEFT INSURANCE FOR GOLF COURSE

LETTER FROM JAMES M. HOLBERT submitting a proposal to cover the Golf Course hose and sprinklers with theft insurance, was read and referred to a committee composed of Councilman Carrick and Hempel for their recommendations.

ORAL COMMUNICATIONS

RATES FOR RENTAL OF CLUB HOUSE Mrs. Carrick addressed the Council stating that she felt the rates charged to organizations for special events were beyond the ability of the organizations to pay, and stated that the organizations had not been officially notified of the new schedule of rates.

The City Clerk stated that the custodian at the Club House had been informed of the new rates.

Councilman Blakelock stated that he had looked into the matter and felt that it was not at all clear "who should pay what". He felt that clarifications should be made as to whether or not clubs making regular use of Club House facilities would be subject to the special event charge, if such special event was scheduled for their regular meeting night.

Following a general discussion of the matter the Mayor appointed a committee composed of Councilmen Blakelock and Hempel to work out the discrepancies existing in the report of the Committee which had been appointed several meetings past relative to new rates, and make definite recommendations at the next regular meeting. It was agreed

to defer the fee for special event charges until the report was forthcoming from the Committee.

REQUEST FOR LIST OF FREE USERS OF GOLF COURSE Mr. Blackden addressed the Council objecting to persons playing at the Golf Course gratis, and requested a list of what he termed "dead-heads" who used the Course.

The Mayor stated that such a list would be made available.

TRASH PICK-UP FOR STAN HERRING'S CABANAS Mr. Stan Herring addressed the Council requesting that trash pick-up services be extended to include the cabanas at the beach, and the Mayor appointed Councilman Carrick and the Superintendent of Public Works to confer with Mr. Herring and work out an arrangement.

FIRE HAZARD NEAR CABANAS Mr. Herring reported that people were building fires in the vicinity of his cabanas, creating a fire hazard. The Mayor stated that the Chief of Police, Arthur Daneri, and Police Commissioner Fortune, would look into the situation.

REPORTS OF SPECIAL COMMITTEES AND OFFICIALS

BIDS RE-SALE OF LOT 1, BLOCK 4, TRACT 795 The matter of selling a section of Lot 1, Block 4, Tract 795 to the client of Adele Gimbal, which was referred to a committee composed of Mayor Read and Councilman Hempel at the meeting of July 16, 1952, was considered. The City Engineer, William A. Ayer, presented a plot plan of the property in question and Mr. McKinney pointed out that it would be necessary to set a price for the sale of the property and call for bids.

The Mayor instructed the City Engineer to prepare a metes and bounds description of the property and upon setting the minimum bid price for the sale, stated it would be advertised that bids would be opened the second meeting of September.

IT WAS MOVED BY COUNCILMAN HEMPEL SECONDED BY COUNCILMAN BLAKELOCK that the Council set a minimum bid price on the property and upon receiving a legal description from the City Engineer, advertise for bids to be opened the second meeting in September.

COMMISSIONS ON SALE OF CITY-OWNED PROPERTY Report of Mayor Read and Councilman Hempel regarding Real Estate Commissions in connection with the sale of City-owned property as recommended by the San Clemente Board of Realtors.

The Committee recommended that the City Council adopt the schedule of commissions as presented by the San Clemente Board of Realtors, and UPON MOTION OF COUNCILMAN BLAKELOCK SECONDED BY COUNCILMAN CARRICK AND UNANIMOUSLY CARRIED the recommendations of the Committee were accepted.

"NO-PARKING" ON SERRA Report of Councilman Fortune and Chief of Police Arthur Daneri regarding the request of Mr. and Mrs. Lessman that a noparking zone be established on the north side of Serra Avenue, the Committee recommended that a no-parking zone be established. The matter was referred to Resolutions (see Resolution No. 583).

REQUEST THAT ALLEY BE MADE A ONE-WAY THOROUGHFARE

Report of Councilmen Blakelock and Fortune regarding the request of Mr. H. J. Bateson that the alley between Granada and Del Mar Avenues be made into a one-way thoroughfare.

BOLSTER FOR DAMAGED BUILDING The Committee recommended that at the expense of the property-owner, a concrete bolster be allowed to be placed in the alley two feet from the building damaged by trucks, until such time as the City might desire to use the space occupied thereby. The Committee further recommended that (1) to avoid traffic meeting in the alley while vehicles are parked there and (2) to prevent traffic from emerging from the alley on to Del Mar Avenue where vision is obstructed by diagonal parking, travel through the alley be regulated as follows:

From Del Mar to Granada Avenues as one-way in a southerly direction, From Del Mar to Cabrillo as one-way in a northerly direction.

The Committee felt that because of excessive speed on Del Mar, and people emerging from the alley on to Del Mar, there is a decided chance of a bad accident occurring.

LOADING ZONE ON DEL MAR AND HIGHWAY 101

It was suggested by Mr. Campbell that loading zones be established on Del Mar and Highway 101 to eliminate the necessity for trucks to park in the alley. However, it was determined that such loading zones would eliminate much needed parking areas for other vehicles on both streets, and therefore the matter was not considered.

The matter of one-way traffic through the alley was referred to Resolutions (see Resolution No. 584).

It was suggested by the City Attorney that Mr. H. J. Bateson obtain permission from the City to construct the concrete bolster in the alley.

MARBELITE STANDARDS FOR STREET LIGHTING

Report of Councilman Blakelock regarding bids for furnishing Marbelite type Lighting Standards to the City, was read: It was recommended that the bid of the Electric Supplies Distributing Company of Santa Ana in the amount of \$5,052 be accepted and awarded.

BID AWARDED ELECTRIC SUPPLIES DISTRIBUTING COMPANY IT WAS MOVED BY COUNCILMAN HEMPEL SECONDED BY COUNCILMAN FORTUNE that the report of the Committee be accepted, and the bid in the sum of \$5,052 for furnishing 20 Marbelite Lighting Standards and appurtenances to the City, be awarded to the Electric Supplies Distributing Company.

BILLING NON-PROFIT ORGANIZATIONS FOR WATER

Mr. Carrick reported that at their last meeting, the Citizens' Water Committee recommended that non-profit organizations be billed for their use of water.

REPORTS OF COUNCILMEN

PLAN TO AND PLAY-GROUNDS

Councilman Hempel outlined his plan to IMPROVE PARKS provide additional capital improvements to various parks and playgrounds' facilities and advised the Council that it might be necessary to exceed the appropriations authorized in the budget this year to complete the projects. Councilman Blakelock remarked that the general public was confused as to what the future plans are with regard to the sale of the Beach Club, and in the event that the Beach Club is sold, what sections of beach will be purchased with the proceeds of the It was recommended that the public be fully informed of the various locations which might be purchased.

PUBLICIZE DATE ALLEY IS MADE ONE-WAY Councilman Blakelock stated that the "San Clemente Sun" should be informed as to the date the alley would be converted to a one-way thoroughfare, in order to fully advise the citizens, and recommended that this be coordinated with the purchase and erection of the signs designating it a one-way thoroughfare.
