#### 2. APPROVAL OF MINUTES

# A. April 9, 2024 Beaches, Parks and Recreation Commission Meeting Minutes

MOTION BY COMMISSIONER ELLIOTT, SECOND BY COMMISSIONER ROUSSEAU, AND CARRIED 6-0, CHAIR FEUERSTEIN ABSENT, to approve the minutes of the Beaches, Parks and Recreation Commission Meeting of April 9, 2024.

#### 3. ORAL COMMUNICATIONS

<u>William Scott</u>, Dana Point, expressed concern about updating and expanding the existing Ralphs Skate Park.

MOTION BY COMMISSIONER ELLIOTT, SECOND BY COMMISSIONER JOHNSON, AND CARRIED 6-0, CHAIR FEUERSTEIN ABSENT, to agendize further discussion of the skatepark for the next regularly scheduled meeting on August 13, 2024.

#### A. Recreation Activities and Events

Beaches, Parks and Recreation Director Wylie, provided an update on the success of San Clemente Arbor Day, Cinco De Mayo Fiesta, and the Memorial Day Observance. She reminded the Commission of the several upcoming special events open to the public.

#### 6. **NEW BUSINESS**

#### A. Review and Consideration of Applications for Aquatics Partnership Status

Director Wylie presented the staff report and responded to Commissioners inquiries.

<u>Mark Matheson</u>, President of the San Clemente Aquatics Team, expressed his concerns regarding SCAT being downgraded from Senior to Junior Aquatics Partnership. He also expressed his concerns regarding the Partnership Policy and the percentage of residents needed to receive the Senior Aquatics Partnership.

<u>Logan Powell</u>, Club Director for the San Clemente Water Polo, expressed his concerns regarding the Partnership Policy.

MOTION BY COMMISSIONER ELLIOTT, SECOND BY COMMISSIONER WEINSTEIN, AND CARRIED 4-2, CHAIR FEUERSTEIN ABSENT, (CHAIR PRO TEM KWESKIN AND COMMISSIONER ROUSSEU VOTING NOE) to support the staff recommendation to grant Junior Partnership status to the San Clemente Tritons Water Polo Corporation for a two-year agreement.

MOTION BY CHAIR PRO TEM KWESKIN, SECOND BY COMMISSIONER JOHNSON, AND CARRIED 5-1, CHAIR FEUERSTEIN ABSENT, (COMMISSIONER ELLIOTT VOTING NOE) to grant San Clemente Aquatics Team Senior Partnership for one year and re-evaluating resident percentages next year.

MOTION BY COMMISSIONER ROUSSEAU, SECOND BY COMMISSIONER GRACE, AND CARRIED 6-0, CHAIR FEUERSTEIN ABSENT, to recommend Council review the policies for Senior Partnership for Aquatics.

#### B. Consideration of Applications for Sports Partnership Status

Director Wylie presented the staff report and responded to Commissioners inquiries.

<u>David Kendall</u>, AYSO, requested an extension to update their rosters with new addresses for residents; and expressed his concerns regarding military families.

In response to Commission inquiries, Director Wylie clarified that active military receives the City of San Clemente resident discount.

MOTION BY COMMISSIONER WEINSTEIN, SECOND BY COMMISSIONER JOHNSON, AND CARRIED 5-1, CHAIR FEUERSTEIN ABSENT, (CHAIR PRO TEM KWESKIN VOTING NOE) to support staff recommendation to grant Tier II Recreational Sports Partnership Status to Elite Soccer League and San Clemente Youth Football for a three-year term, and Tier II Recreational Sports Partnership to AYSO for a one-year term and come back next year with updated rosters.

## i. Master Plan Update - Richard T. Steed Park

Director Wylie indicated that the final look at the 24-court pickleball design and amending the environmental findings will be going to the City Council on June 18, 2024, for review and consideration.

Director Wylie also indicated that Council has approved a 2-year budget and a component of that was funding for an expansion of the existing skatepark.
