CONSIDERATION OF THE FY 2024-25 BEACHES, PARKS & RECREATION COMMISSION WORK PLAN

Fiscal Impact:

Projects included in the proposed Work Plan are either currently funded or will be considered for funding through a future annual budget process.

Summary:

Pursuant to the City Council's direction, the Beaches, Parks & Recreation Commission has prepared the attached draft Work Plan for FY 2024-25 for City Council consideration. The purpose of the Work Plan is to provide direction and objectives to the Commission for FY 2024-25.

Background:

At its August 8, 2024, regular meeting, the Commission reviewed several items under consideration for its FY 2024-25 Work Plan. The following items were recommended for approval; full details are included in Resolution Exhibit "A".

- 1. Cost of services study review for the use of beaches, parks, and recreation facilities.
- 2. Review of concept designs for the playground replacement projects at Forster Ranch Community Park and Talega Park.
- 3. Review of designs for the anticipated expansion of the skate park.
- 4. Participation in and review of the conceptual designs for two new dog parks located and San Luis Rey Park and San Gorgonio Park.
- 5. Consideration and review of the anticipated designs of the meadow field space at Vista Hermosa Sports Park.
- 6. Update the Aquatics Partnership Policy.
- 7. Overview/special presentation of the current master plan for the department.
- 8. Add an Events Subcommittee.

WHEREAS, the Beaches, Parks & Recreation Commission is established to act in an advisory capacity to the City Council in all matters pertaining to parks, beaches, recreation, parkways, street trees; and

WHEREAS, the San Clemente Municipal Code § 2.28.020(d) requires that the Beaches, Parks & Recreation Commission develop an annual work plan with specific goals and objectives for the coming year and submit it to the City Council for approval each year; and

WHEREAS, on August 13, 2024, the Beaches, Parks and Recreation Commission held a special meeting to review and recommend approval of seven items to be included in its FY 2024-25 Work Plan.

NOW, THEREFORE, the City Council of the City of San Clemente does hereby resolve as follows:

Annual Work Plan: Beaches, Parks & Recreation Commission (FY 2024-25)

Project Name: (No. 1) Cost of services study review for the use of beaches, parks, and recreation facilities Purpose, Goals, and Deliverables of Project: Update Recreation Fee Schedule to ensure adequate cost recovery of all parks and recreation services, including programs, events, facilities and permits; Fees for Beaches, Parks, and Recreation facility rentals and services were last updated and approved in 2015. This project seeks to better align existing fees for facility rentals and services with industry standards and comparable agencies, as well as implement new fees that are relevant to current operations. Updated fee structures will likely deliver increased revenue; Final recommendations will be presented to the City Council for adoption. Estimated Project Costs. Purpose, Goals, and Deliverables of Project:

Engage with the community to support the replacement of two playgrounds at City parks. These two playgrounds have been identified as the top replacement needs. Staff will work with the Commission to listen to public feedback to determine best structures and surfacing. Final designs will be forwarded to Council for award of contract and approval.
