A. Local Coastal Plan projects funded by a Coastal Commission Grant

The California Coastal Commission awarded a \$1.5 Million grant in July of 2024, and the grant agreement was executed in October. The agreement covers several tasks, listed below, which staff will preview for the Planning Commission. These tasks are scheduled to be completed by the end of 2026.

- Task 1: South Orange County Sand Source Investigation
- Task 2: Complete LCP Implementation Plan, including a Parking and Transportation Demand Management Plan as well as a Lidar survey and geotechnical analysis
- Task 3: Targeted Land Use Plan Amendment(s) to incorporate findings & recommendations
