# FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT FOR

This First Amendment to Professional Consultant Services Agreement for Columbo Inclinometer and Geotechnical Investigation, PN 24200 (this "First Amendment") is made and entered into on this 12 day of 100 by and between the CITY OF SAN CLEMENTE, a California municipal corporation ("City"), and LGC Geotechnical, Inc. ("Consultant").

### RECITALS:

- A. City and Consultant entered into that certain Professional Consultant Services Agreement for Columbo Inclinometer and Geotechnical Investigation, PN 24200 (the "Agreement") on July 29, 2024.
- B. City and Consultant desire to amend the Agreement in the manner provided herein.

#### COVENANTS:

Section 1.1 of the Agreement is hereby amended by increasing the total compensation from Forty-Three Thousand Dollars (\$43,000) to Forty-Seven Thousand, Seven Hundred and Fifty Dollars (\$47,750). In addition to the services to be performed by Consultant as referenced in Exhibit A to the Agreement, Consultant shall also perform those services described in Exhibit "A" to this First Amendment, which exhibit is attached hereto and incorporated herein by this reference.

This First Amendment and the Agreement may be executed electronically with the same force and effect as original ink signatures.

Except as expressly amended by this First Amendment, the remaining portions of the Agreement shall remain in full force and effect.
