# C. <u>Presentation by SunCal, LLC - Status of the Marblehead Residential/SunCal</u> <u>Project</u>

<u>Dave Placek</u>, SunCal, LLC, explained that the Marblehead residential/SunCal project is basically in a holding pattern until the bankruptcy court authorizes expenditures or Lehman Brothers negotiates for disposition of assets, which could include Marblehead Coastal.

Council directed that SunCal updates be agendized for the first Council meeting of each month, instead of being agendized for two Council meetings per month.

#### 5. **CLOSED SESSION REPORT – CITY ATTORNEY**

City Attorney Oderman stated that no reportable actions were taken during the Closed Session portion of the meeting.

#### 6. PUBLIC HEARINGS

### A. <u>213 Avenida Del Mar (Nick's Restaurant) - Conditional Use Permit 08-</u> 314/Cultural Heritage Permit 08-315

Public Hearing to consider a request to convert a previous retail store (The Rug Gallery) into a new restaurant. Improvements include a façade remodel, a 667 square foot open patio dining area within the existing building envelope, and a new trash enclosure. The project site is located at 213 Avenida Del Mar within the Mixed Use, Central Business and Architectural Overlay (MU3-CB-A-CZ) zoning districts.

City Planner Pechous narrated a PowerPoint presentation entitled "Nick's Restaurant and Cellar Gourmet Deli"; proposed a new condition to require two additional pole lights in the parking lot; responded to questions from Council. A hard copy of Mr. Pechous' presentation, dated March 3, 2009, is on file with the City Clerk.

Mayor Donchak opened the Public Hearing.

<u>Charles Ram</u>, project architect, described the project and emphasized the Applicant's desire to work with the City to achieve a product that reflects the community's desires. In response to Council comment, Mr. Ram discussed alternatives being considered to improve the rear façade.

<u>Scott McIntosh</u> and <u>Nick Nickoloff</u>, Applicants, advised that the proposed number of seats is necessary for the restaurant's financial viability.

<u>David Kenworthy</u>, representing the restaurant's ownership, commented that the exterior façade and building improvements are estimated to cost \$1 million; noted that he was initially reluctant to open the on-site parking lot for public use, but later determined to do so because he realized that it was in the community's best interest; related that the restaurant hopes to draw patrons from surrounding cities.

There being no others desiring to speak to this issue, the Public Hearing was closed.

During the course of deliberations, individual Councilmember(s) offered commentary as follows. The below points do not necessarily reflect Council consensus.

- The rear of the building is not as attractive as the front of the structure.
- The trash enclosure at the rear of the building should not be located next to the main steps.
- Opening the on-site parking lot to public use will take away parking needed for Nick's Restaurant.
- Opening the on-site parking lot to public use is anticipated in the Walker Parking Study to improve accessibility and parking turn-around times, and prohibit long-term vehicle storage.
- Adding another restaurant in the 200 block of Avenida Del Mar increases the "restaurant row" concept and increases the parking demand.
- The parking lot at 215 Avenida Granada should be opened for public use and be adequately illuminated.
- It is unfair to condition the project on the owners of the adjacent parking lots agreeing to open their lots to public use.
- The parking lot of the subject site and adjacent parking lots could be improved with additional lighting and surface grade leveling.
- The project meets the criteria for outdoor seating waivers in accordance with the original Walker Downtown Parking Study and its subsequent affirmations.
- No outdoor seating waivers have been issued since 2002, and additional waivers are still available.
- Outdoor seating has been proven to enhance the Downtown experience.

- The availability of parking in the rear of the restaurant should be advertised via signage.
- The proposed Spanish Colonial Revival Architecture will improve the building façade and enhance the overall Downtown appearance and character.
- Approval of parking waivers for this project, and the resulting decrease in available parking in the Downtown area, will discourage people from visiting the area.
- Approval of this project could decrease available parking to the point that the Downtown area gains a reputation for parking shortages, thereby negatively impacting existing businesses.
- The increased number and variety of restaurants concentrated in one area establishes a destination district and improves the quality of the Downtown experience.
- In a destination district situation, restaurant patrons that discover upon arrival that their intended restaurant has no seating available will have the option to patronize another area restaurant.
- The project will offer a product that has been proven to be successful, and will be an excellent addition to the Downtown area.

MOTION BY COUNCILMEMBER ANDERSON, SECOND BY MAYOR PRO TEM DAHL, CARRIED 3-2 (COUNCILMEMBER BAKER AND COUNCILMEMBER EGGLESTON VOTING NOE), to adopt Resolution No. 09-15 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING CONDITIONAL USE PERMIT 08-314 AND CULTURAL HERITAGE PERMIT 08-315, NICK'S RESTAURANT, A REQUEST FOR THE ONSITE SALE AND CONSUMPTION OF ALCOHOL, OUTDOOR DINING EXCEEDING 16 SEATS, THE WAIVER OF FOUR PARKING SPACES, AND REMODEL OF AN EXISTING RESTAURANT BUILDING LOCATED AT 213 AVENIDA DEL MAR, with the addition of a 14<sup>th</sup> Condition to read as follows:

"The applicant shall install and maintain a minimum of two light poles to be located within the on-site parking lot. The light poles shall meet City standard requirements for lighting and shall be reviewed and approved by the City Planner prior to installation."

# B. <u>156 Avenida Del Mar (The Cellar Gourmet Deli) - Amendment to Conditional</u> Use Permit 07-387

Public Hearing to consider a request to amend a previously approved Conditional Use Permit to extend the hours of an existing restaurant to the daytime that involves the sale of beer and wine for on-site consumption and non-amplified live entertainment, and a request for approval of off-site parking in conjunction with the new daytime weekend hours. The existing restaurant is located at 156 Avenida Del Mar, the legal description being Lot 39, Block 5 of Tract 779.

City Planner Pechous narrated a PowerPoint presentation entitled "Nick's Restaurant and Cellar Gourmet Deli," and responded to questions from Council. A hard copy of Mr. Pechous' presentation, dated March 3, 2009, is on file with the City Clerk.

Mayor Donchak opened the Public Hearing.

<u>Dawn Mendes</u>, <u>Sheri Jordan</u> and <u>Crystal Adams</u>, Applicants, advised that their intent to open during the day was prompted by customer demand and the expectation of additional business activity; stated that they lose a significant amount of business between 4:00 p.m. and 5:00 p.m.; related their willingness to self-regulate; noted that the parking shortage exists during weekdays only since they have contracted for additional parking during weekends; stated that they gave up their parking to provide public parking; pointed out that it will take at least one month for them to receive ABC approval of the extended hours.

<u>Greg Davidson</u>, Laguna Niguel, advised that he is a patron of The Cellar and supports the Applicant's request for additional hours and parking waivers.

There being no others desiring to speak to this issue, the Public Hearing was closed.

During the course of deliberations, individual Councilmember(s) offered commentary as follows. The below points do not necessarily reflect Council consensus.

- It would be beneficial for Staff to document parking availability in the 100 block of Avenida Del Mar for Council consideration.
- A parking waiver may not be needed to enable The Cellar to open on weekdays at 4:00 p.m. or 5:00 p.m. if it can be documented that sufficient parking is available during those hours.
- Self-regulation, if approved, could establish an undesirable precedent and necessitate monitoring by the City's code enforcement staff.

- It is unfair to disallow parking waivers in the 100 block of Avenida Del Mar while allowing parking waivers in the 200 block.
- A discussion with the Walker Study consultants may lead to alternative solutions for businesses seeking parking in the 100 block of Avenida Del Mar.

MOTION BY COUNCILMEMBER BAKER, SECOND BY COUNCILMEMBER EGGLESTON to adopt Resolution No. 09-16 entitled a RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING AN AMENDMENT TO CONDITIONAL USE PERMIT 07-387, THE CELLAR GOURMET DELI, A REQUEST TO AMEND A PREVIOUSLY APPROVED CONDITIONAL USE PERMIT TO EXTEND THE HOURS OF AN EXISTING RESTAURANT TO THE DAYTIME THAT INVOLVES THE SALE OF BEER AND WINE FOR ON-SITE CONSUMPTION AND NON-AMPLIFIED LIVE ENTERTAINMENT, AND A REQUEST FOR APPROVAL OF OFF-SITE PARKING IN CONJUNCTION WITH THE NEW DAYTIME WEEKEND HOURS FOR THE EXISTING RESTAURANT LOCATED AT 156 AVENIDA DEL MAR.

- 2. Direct Staff to expedite for Council consideration the issue of parking waivers during weekday daytime hours. This issue is to be agendized for the Council meeting of April 7, 2009.

#### A. Contract Award - City-Wide Strategic Planning Process

Report from the Assistant City Manager concerning the selection of a professional services contractor to provide Strategic Planning Process services.

Human Resources Manager Penrod summarized the Administrative Report and responded to Council inquiries.

Council discussion ensued relative to the benefits of retaining MIG to provide expert strategic planning services versus not contracting the work and utilizing the monetary savings to implement projects.

- 1. Approve, and authorize the Mayor to execute, Contract No. C09-13, by and between the City of San Clemente and MIG, Inc., providing for a Citywide Strategic Planning Process, in an amount not to exceed \$138,501.
- 2. Approve an appropriation of \$38,500 from the undesignated fund balance to Account 001-203-45900-000-39801.
- 3. Authorize an appropriation of no more than \$22,000 from the undesignated fund balance to Account 001-203-45900-000-39801 for the two optional services (photosimulation services and web-based visual preference exercise services) as outlined in Exhibit A of the proposed contract.

#### B. Economic Development Position

Report from the City Manager concerning the creation of an Economic Development position.

City Manager Scarborough reviewed the Administrative Report and responded to Council inquiries.

Council discussion followed relative to 1) the pros and cons of establishing an Economic Development position during the current recession; and 2) prudence of authorizing the creation and recruitment of an Economic Development position at this time versus deciding the issue in conjunction with the City's FY 2010 budget.

MOTION BY MAYOR DONCHAK, SECOND BY COUNCILMEMBER EGGLESTON, CARRIED 3-2 (COUNCILMEMBERS BAKER AND ANDERSON VOTING NOE), to 1) direct the City Manager to pursue a Director of Housing and Economic Development classification that is equivalent to the salary range of the City's Community Development Director classification, 2) authorize a full-time, benefited Administrative Assistant position to handle the administrative duties that would accompany the position, and 3) direct the City Manager to commence the recruitment.

#### 9. **NEW BUSINESS**
