MOTION BY MAYOR DAHL, SECOND BY COUNCILMEMBER ANDERSON, CARRIED 5-0, to recess to Closed Session at 5:01 p.m. to discuss the following:

A. Presentation of Proclamation - Multiple Sclerosis Awareness Week

Mayor Dahl presented a proclamation to Shashona Reynolds, National Multiple Sclerosis Pacific South Coast Chapter Board Member and Ambassador, proclaiming March 8-12, 2010 as Multiple Sclerosis Awareness Week.

D. <u>Presentation by League of California Cities - Initiative to Prevent State Raids and Borrowing of Local Government and Transportation Revenues</u>

Presentation by Tony Cardenas, Public Affairs Regional Manager of the Orange County Division of the League of California Cities, concerning an initiative to prevent State raids and borrowing of revenues dedicated for local government services, transportation projects and transportation services.

Council continued this item to the Council meeting of March 16, 2010.

E. <u>Presentation by SunCal, LLC - Status of the Marblehead Residential/SunCal</u> Project

Presentation by SunCal concerning the status of the Marblehead residential/SunCal project.

<u>Peter Johnson</u>, representing SunCal, provided an update on the status of the Marblehead residential/SunCal project; reported that it is anticipated that SunCal will request a 90-day funding authorization extension for the continuation of erosion control, fencing repairs and mitigation work; offered to provide cost estimates and contract request documents to Staff for the projects identified in the Settlement Agreement with Arch Insurance Company. In response to Council inquiry, Mr. Johnson agreed to investigate and address damage to the perimeter fencing.

Council requested that Staff communicate with the Sheriff's Department concerning the possibility of enforcing traffic regulations on Avenida Vista Hermosa in the vicinity of Shorecliffs Middle School.

F. <u>Tri-City Trolley - Status Report</u>

Report from Councilmember Eggleston concerning the status of the Tri-City Trolley.

Councilmember Eggleston narrated a PowerPoint presentation entitled "OCTA Go Local Program Step 2 Tri-City Trolley" and responded to Council inquiries.

G. <u>Downtown Fire Station/Senior Center Construction Update</u>

Report from the Community Development Director concerning the status of the construction of the Downtown Fire Station and Senior Center.

Building Official Jorgensen narrated a PowerPoint presentation entitled "Downtown Fire Station and Senior Center" and responded to Council inquiries.

2. ORAL COMMUNICATIONS (PART ONE)

City Budget Deficit - La Pata/Vista Hermosa Sports Park

<u>Doug Younkin</u>, San Clemente, voiced concern that insufficient funding is available to construct the La Pata/Vista Hermosa Sports Park; suggested that the City implement employee pay freezes, furloughs, and retirement benefit reductions to reduce the projected deficit.

<u>Stevie Younkin</u>, San Clemente, suggested that Council consider imposing employee pay freezes, increasing the retirement age, and transferring police and fire services to the City to reduce the budgetary deficit.

<u>John Openshaw</u>, San Clemente, recommended that Council commission a feasibility study to assess various retirement benefit options that could help reduce the projected City budget shortfall.

City Sports Facilities and Infrastructure

<u>David Dimond</u>, San Clemente, voiced support for the construction of sport facilities and urged Council to make the difficult decisions necessary to fund infrastructure improvments.

Leslie Park Fence - Vandalism at Sea Cliff Villas

<u>Larry Culbertson</u>, San Clemente, commended the high quality and aesthetics of the new Leslie Park fence; pointed out that vandals broke several windows at Sea Cliff Villas.

Emergency Preparedness Responsibility

<u>Lyn Harris Hicks</u>, San Clemente, stated that the Federal Emergency Management Agency (FEMA) has indicated that the City's emergency preparedness plans are well prepared; conveyed that FEMA has expressed that it is the responsibility of the City and State to protect the general public.

<u>Safety Violations at San Onofre Nuclear Generating Station (SONGS)</u>

<u>Gary Headrick</u>, San Clemente, pointed out that more than 60 persons have written letters to express safety concerns regarding the San Onofre Nuclear Generating Station; reviewed safety violations identified in the Nuclear Regulatory Commission's quarterly report for SONGS.

3. MOTION BY COUNCILMEMBER ANDERSON, SECOND BY COUNCILMEMBER EGGLESTON, CARRIED 5-0, to waive reading in full of all Resolutions and Ordinances.

Council commended the Planning Commission for its proactive exploration of new ways to serve the community, MOTION BY COUNCILMEMBER DONCHAK, SECOND BY COUNCILMEMBER ANDERSON, CARRIED 5-0, to receive and file the Planning Commission Study Session minutes of February 17, 2010.

D. Parking Prohibitions and Restrictions on Portico Del Sur and Portico Del Norte

Following clarification, MOTION BY MAYOR DAHL, SECOND BY COUNCILMEMBER EGGLESTON, CARRIED 5-0, to adopt Resolution No. 10-15 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING MASTER TRAFFIC RESOLUTION NO. 1846, ESTABLISHING "NO PARKING AREAS" ON PORTICO DEL SUR AND PORTICO DEL NORTE.

This amendment increases the contract amount from \$158,848 to \$188,429 (an increase of \$29,581).

A. <u>Code Amendment - Mission of the Coastal Advisory Committee</u>

Report from the Public Works Director/City Engineer concerning the possibility of amending the Code of the City of San Clemente as it relates to the Coastal Advisory Committee's mission.

Assistant City Engineer Bonigut reviewed the contents of the Administrative Report.

<u>Bill Hart,</u> Chairman of the Coastal Advisory Committee, noted that Council encouraged the Coastal Advisory Committee to develop an action-oriented mission. In response to Council inquiry, Mr. Hart explained that the Committee will not review development projects as a matter of course, but noted that the Council has the discretion to refer individual projects to the Committee if it desires.

MOTION BY COUNCILMEMBER ANDERSON, SECOND BY COUNCILMEMBER DONCHAK, CARRIED 5-0, to introduce Ordinance No. 1500 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING CHAPTER 2.42 OF THE SAN CLEMENTE MUNICIPAL CODE RELATING TO THE COASTAL ADVISORY COMMITTEE MISSION.

B. <u>Fee Waiver Request - Senior Center Facility (San Clemente Friends of the Library)</u>

Report from the Beaches, Parks and Recreation Director concerning the possibility of waiving fees for use of the senior center for the San Clemente Friends of the Library's monthly book sale.

Recreation Manager DiCandia reviewed the contents of the Administrative Report and responded to Council inquiries.

<u>Carla Lalley</u>, representing San Clemente Friends of the Library, explained that book sale revenues have increased since the sale was relocated to the senior center; pointed out that the Friends is a volunteer organization that donates all of its proceeds (i.e., \$50,000+ per year) to the Library to fund additional programs. In response to Council inquiry, Ms. Lalley explained that the monthly book sale was previously conducted in the lobby between the senior center and library.

<u>David Estes</u>, President of the San Clemente Friends of the Library, pointed out that the funds raised by the Friends benefit the City. In response to Council inquiries, Mr. Estes stated that if Council does not grant a fee waiver for use of the senior center, then the book sale will be operated in the lobby that is located between the library and senior center; expressed a willingness to limit the setup and operation of the book sale to Sundays only.

Following discussion, MOTION BY COUNCILMEMBER EGGLESTON, SECOND BY COUNCILMEMBER DONCHAK, CARRIED 5-0, to waive the fees associated with use of the senior center by the San Clemente Friends of the Library for its monthly book sale, with the proviso that the fee waiver shall apply on Sundays only. The Beaches, Parks and Recreation Department is to advise Council if a conflict arises with regard to Sunday rentals.

C. <u>Contract Award - Construction Management of the La Pata/Vista Hermosa</u> <u>Sports Park Project, Phase 1B</u>

Report from the Beaches, Parks and Recreation Director concerning the possibility of awarding a contract for construction management services for the La Pata/Vista Hermosa Sports Park project, Phase 1B.

Landscape Architect Shaw reviewed the contents of the Administrative Report. In response to Council inquiries, Mr. Shaw explained that RBF's proposal is approximately 10% higher than the lowest proposal due to a more-comprehensive list of tasks and close-out phase activities; related that Staff successfully negotiated with RBF to reduce its overall proposal amount.

Following discussion, MOTION BY COUNCILMEMBER ANDERSON, SECOND BY MAYOR PRO TEM BAKER, CARRIED 4-1 (COUNCILMEMBER DONCHAK VOTING NOE), to approve, and authorize the Mayor to execute, Contract C10-07, by and between the City of San Clemente and RBF Consulting, providing for construction management of the La Pata/Vista Hermosa Sports Park, Phase 1B, Project No. 18142, in an amount not to exceed \$907,638.

Report from the Beaches, Parks and Recreation Director concerning amendments to various City maintenance agreements to extend the terms through December 31, 2010.

Beaches and Parks Manager Reed reviewed the contents of the Administrative Report and responded to Council inquiries.

- 1. Approve, and authorize the Mayor to execute, the Second Amendment to Contract C05-32, by and between the City of San Clemente and Stewart and Associates, providing for inland trail maintenance. This amendment extends the term of the contract through December 31, 2010.
- 2. Approve, and authorize the Mayor to execute, the Second Amendment to Contract C08-64, by and between the City of San Clemente and Stewart and Associates, providing for beach trail maintenance. This amendment extends the term of the contract through December 31, 2010.

Discussion ensued relative to the service that Austin-Foust will provide as compared to the work that the Planning Center will perform in developing the City's new Circulation Element.
