# <u>Liquefied Natural Gas (LNG) Receiving Terminal Off Coast of Camp</u> <u>Pendleton</u>

Kathryn DeRusso, San Clemente, stated she read an article in the Los Angeles Times, on June 15, 2004, about the proposed Liquefied Natural Gas (LNG) receiving terminal off the coast of Camp Pendleton; spoke in opposition to the placement of an LNG facility in close proximity to San Clemente; noted that Governor Schwarzenegger's Resource Secretary has indicated that the Governor favors at least one LNG facility in the State of California; urged that San Clemente proactively oppose the subject facility.

Council noted that it has sent a notice of opposition to the development of an LNG facility near San Clemente to approximately 50 legislators and agencies within the Federal and California State governments; explained that Congressman Calvert is also on record as opposing an LNG facility at the subject location; explained that the City will likely consider adopting a resolution of opposition in the near future.

# A. <u>Historic Property Preservation Agreement 03-215, Historic City Hall - 101 South El Camino Real</u>

Public Hearing to consider a request for approval of an Historic Property Preservation Agreement (HPPA) for the purpose of providing potential property tax reduction as an incentive for the property located at 101 South El Camino Real.

Assistant Planner Ah Sing narrated a powerpoint presentation entitled "Historic Property Preservation Agreement 03-215, Historic City Hall" and responded to Council inquiries. A hard copy of Mr. Ah Sing's presentation, dated August 3, 2004, is on file with the City Clerk.

Mayor Ritschel opened and closed the Public Hearing, there being no one desiring to speak to this issue.

MOTION BY COUNCILMEMBER EGGLESTON, SECOND BY COUNCILMEMBER DOREY, CARRIED 5-0, to:

- 1. Adopt Resolution No. 04-67 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, APPROVING HISTORIC PROPERTY PRESERVATION AGREEMENT 03-215 FOR THE PROPERTY LOCATED AT 101 SOUTH EL CAMINO REAL, with the requirement that the exterior building and window trim be painted within three years.
- 2. Authorize the Mayor to execute, and the City Clerk to record, the Historic Property Preservation Agreement for the property at 101 South El Camino Real after the required application fee has been submitted to the City by the property owner. (Contract C97-86)

### B. <u>Encroachment 03-181/Amendment to Site Plan Permit 99-097, Villa</u> Pacifica Gates

Public Hearing to consider a request to allow the installation of vehicle and pedestrian access gates and associated street improvements in Villa Pacifica, a residential subdivision located in the Rancho San Clemente Specific Plan on Via Pacifica between Camino Vera Cruz and Via Onda, the legal description being Lots A, B, C, E and F of Tract 15870.

Assistant Planner Cunningham reviewed the contents of the Administrative Report and responded to Council inquiries.

Mayor Ritschel opened the Public Hearing.

Michael Bunganich, landscape architect for the Villa Pacifica Homeowners Association, offered to answer Council questions concerning aesthetics and landscape issues.

In response to Council inquiry, <u>Valerie Isaksen</u>, President of the Villa Pacifica Homeowners Association, stated that she believes that the residents would support the installation of emergency vehicle preemption devices (i.e., Opticons) at the gates to facilitate access by firefighters and emergency medical personnel, provided the installation is not cost prohibitive.

James Ignacek, President of the homeowners association located directly north of the Villa Pacifica subdivision, conveyed support for Villa Pacifica's plan, including the installation of gates; suggested that the left-turn pocket on Via Onda at the exit gate be re-striped to avoid confusion; noted that a portion of a hillside will be removed to accommodate a turn-around and urged that the City supervise the excavation process and ensure that a suitable retaining wall is constructed.

Traffic Engineer Hindiyeh clarified that signage would be installed on Via Onda to indicate that it is a one-way street and that the subdivision cannot be entered from that location; noted that Via Onda will be re-striped to eliminate the left-turn pocket. With reference to the grading of the hill, Mr. Hindiyeh explained that the proposed Conditions of Approval require that a soils report be provided and that the design of the retaining wall be adequate to support that portion of the hill.

There being no others desiring to speak to this issue, the Public Hearing was closed.

# C. <u>Amendment to Site Plan Permit 02-091, Shea Homes Village 4</u> <u>Replacement Architecture</u>

Public Hearing to consider a request by Shea Homes to replace previously approved architecture for 72 single-family homes within Planning Area 4B of the Talega Specific Plan. The site is a portion of Tentative Tract Map 16335, located generally northwest of Calle Saluda and Avenida Talega.

Planning Consultant Morrow reviewed the contents of the Administrative Report.

In response to Council inquiry, <u>Cole Theel</u>, on behalf of the Applicant, stated that he assumes that the subject homes will have a view of the future park at La Pata and Vista Hermosa since the homes were redesigned to provide views of the surrounding areas.

Mayor Ritschel opened and closed the Public Hearing, there being no one desiring to speak to this issue.

MOTION BY MAYOR PRO TEM ANDERSON, SECOND BY COUNCILMEMBER EGGLESTON, CARRIED 5-0, to adopt Resolution No. 04-69 entitled A RESOLUTION OF THE CITY COUNCIL OF THE CLEMENTE, CALIFORNIA, **APPROVING CITY** OF SAN **AMENDMENT** TO PERMIT SITE PLAN 2002-091, **TALEGA** PLANNING AREA 4B, A REQUEST TO REVISE THE PREVIOUSLY **ARCHITECTURE AND MINOR** LOT APPROVED LINE MODIFICATIONS FOR 72 SINGLE-FAMILY HOMES WITHIN TRACT 16569 LOCATED NORTHWEST OF CALLE SALUDA AND AVENIDA TALEGA, with an additional condition to require that the disclosures document that is provided to potential homebuyers clearly reveal the existence of a lighted sports field park at the intersection of La Pata and Vista Hermosa.

# 8. <u>NEW BUSINESS</u>

# A. Establishment of Speed Limits on City Streets

Report from the Public Works/Economic Development Director concerning the establishment of speed limits on City Streets.

Traffic Engineer Hindiyeh reviewed the contents of the Administrative Report; noted that in order for speed limits to be valid and enforceable by the courts, State law requires that engineering and traffic surveys be conducted every five years and that speed limits be established at or near the speed at which 85% of the surveyed motorists drive; reviewed the speed survey procedure and responded to Council inquiries.

During the ensuing discussion, Council expressed concern with the proposal to increase speed limits on segments of Avenida Pico, Avenida Vista Hermosa, Avenida La Pata, Calle Del Cerro and Sarmentoso; voiced disagreement with State statutes that require that speed limits be established near the 85<sup>th</sup> percentile speed in order to be enforceable, since this constraint does not allow unique conditions that warrant lower speed limits to be taken into consideration.

Lyn Harris Hicks. San Clemente, questioned, and received clarification, that Council is not considering lowering speed limits on some streets to 10 miles per hour; recommended that the City request that the legislation be amended to allow factors, such as accident records and speed consistency with adjoining streets, to be taken into account.

MOTION BY MAYOR PRO TEM ANDERSON, SECOND BY COUNCILMEMBER EGGLESTON, CARRIED 5-0, to:

1. Approve the establishment of speed limits on City streets as identified in the Administrative Report, with the exception of the proposed speed limit increases on segments of Avenida Pico, Avenida Vista Hermosa, Avenida La Pata, Calle Del Cerro and Sarmentoso.

- 2. Introduce Ordinance No. 1293 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING CHAPTER 10 OF THE MUNICIPAL CODE CONCERNING SPEED ZONES ON CITY STREETS, as amended to delete those street segments that were exempted from Action #1.
- 3. Direct Staff to further research those street segments that were excluded from Action #1.

Council requested that Staff provide a report that identifies the number of accidents that have occurred, and speeding citations that have been issued, on Avenida Pico, Avenida Vista Hermosa, Avenida La Pata, Calle Del Cerro and Sarmentoso.

# B. <u>Downtown Business Association (DBA) "Puttin" on the Glitz" Special</u> <u>Event</u>

Report from the Director of Beaches, Parks and Recreation concerning the proposed "Puttin' on the Glitz" special event.

Recreation Manager Mead reviewed the contents of the Administrative Report and responded to Council inquiries.

Nicole Corwin, Managing Director of the DBA, stated that the DBA is requesting City partnership of the "Puttin on the Glitz" event because it has become extremely successful; noted that the DBA is proposing that the duration of the event be extended to three weekends to alleviate the congestion associated with a condensed event; reviewed the plan in terms of traffic circulation and parking, noting that volunteers will be utilized to direct visitors to available parking spaces; stated that the DBA is requesting approval for the proposed street closure, fee waivers, approval of holiday entertainment along the sidewalks, and commencement of the two-year process necessary for partnership status.

MOTION BY MAYOR PRO TEM ANDERSON, SECOND BY COUNCILMEMBER DAHL, CARRIED 5-0, to approve the DBA's "Puttin' on the Glitz" special event and fee waiver request for 2004 and consider the event for partnership status in 2005.

(3) Orange County Fire Authority Status Update.

Councilmember Dahl reported that OCFA strike teams have assisted in fighting fires throughout Southern California and Las Vegas.

# (4) San Clemente-Dana Point Animal Services Authority.

Councilmember Dahl reported on animals available for adoption at the San Clemente-Dana Point Animal Services Authority; thanked the shelter volunteers, veterinarians and staff; reported on the "Pendleton Patriots" program that is intended to help the Camp Pendleton shelter showcase pets that are available for adoption as a result of the large number of deployments from the base.

# (5) Transportation Corridor Agencies Status Report.

Councilmember Dahl reported that August 6, 2004 is the deadline for the TCA to receive comments on the draft Environmental Impact Report for the 241 Foothill-South Transportation Corridor; stated that a petition is being circulated in San Clemente in opposition to the central corridor alignment; stated that he was re-elected as Chairman of the Budget and Operations Committee for the San Joaquin Hills Transportation Corridor.

# Results of Orange County Vector Control District Mail Ballot Election

Mayor Pro Tem Anderson advised that the ballot measure relating to funding for continuation of certain Orange County Vector Control District programs passed with a 66% approval rate; stated that he will attend a Board meeting on August 5, 2004, at which time the Board is scheduled to vote to implement the ballot initiative.

# <u>Directional Signage to Municipal Golf Course/Inclusion of Human Affairs Committee Meeting Notices in Water Bills</u>

Mayor Pro Tem Anderson requested that Staff pursue the matter of directional signage for the Municipal Golf Course, both on the I-5 (which requires Caltrans approval) as well as various locations within the City; requested that the City Manager investigate the possibility of announcing Human Affairs Committee public forums in water bills.

#### Miramar Theatre

Councilmember Eggleston noted that the Miramar Theatre has a new owner; acknowledged that Councilmembers may have different views about the land usage at the site, but suggested that applications for the site should be processed in a timely manner instead of being delayed until the visioning process is complete.

#### New City Hall Site

Council determined to consider the process and timeline for acquiring a new City Hall site during the Long-Term Financial Plan process.

### New Senior Center (Dinner/Dance Fundraiser)

Councilmember Dorey advised that a dinner/dance will be held on September 18, 2004 to raise funds for a new senior center in San Clemente.

### "Relay for Life" - American Cancer Society Fundraiser

Mayor Ritschel reported on the success of the "Relay for Life" that was held at San Clemente High School last weekend to raise funds for the American Cancer Society; noted that this is the first time the event has been held in San Clemente and explained that the event raised \$50,000, which surpassed expectations.

#### **OCTA Community Circulator Bus**

Mayor Ritschel advised that the OCTA launched its Community Circulator Bus on July 31, 2004 at the WalMart center; noted that the bus will circulate between the K-Mart Center, Plaza Pacifica and North Beach; advised that the route will be expanded to include Marblehead Coastal when developed and expressed hope that the route can also be adjusted to include the downtown area.
