# PLEDGE OF ALLEGIANCE

## 1. SPECIAL PRESENTATIONS

## A. Red Ribbon Week Proclamation

Mayor Anderson presented a proclamation to Jan Sener, Janet Dunford and Leslie Haight, of Police Services Crime Prevention, declaring October 23-30, 2005 as Red Ribbon Week.

# B. Commendation - Lee Steelman

Mayor Anderson presented a commendation to Lee Steelman in recognition of 26 years of volunteer service as Executive Director of the South Orange County Community Services Council.

# C. Measure M Presentation

Monte Ward, Director of Special Projects of the Orange County Transportation Authority, narrated a powerpoint presentation entitled "Measure M: Your ½-Cent Sales Tax for Transportation at Work". A hard copy of Mr. Ward's presentation, dated October 18, 2005, is on file with the City Clerk.

Mary McMenamin, San Clemente, expressed support for Measure M inasmuch as she feels it is a much-needed funding source for Orange County's transportation needs.

Peter van Nuys, San Clemente, voiced concern that the I-5 is congested and getting worse; asserted that the 241 Tollroad will do little, if anything, to relieve freeway traffic; commented that CalTrans has drafted plans to add two lanes in each direction on the I-5, but little is heard about those plans because the TCA's "non-compete" requirement makes it difficult for CalTrans to promote its projects; requested that the improvement of the I-5 through South County, and San Clemente in particular, be added to OCTA's project list.

2. MOTION BY COUNCILMEMBER DAHL, SECOND BY COUNCILMEMBER RITSCHEL, CARRIED 4-0, to waive reading in full of all Resolutions and Ordinances.

# 4. ORAL COMMUNICATIONS (PART ONE)

Bert Abley stated that he resides on Calle de los Alamos, directly next to the beach access; stated that the City surveyed the access a few months ago in connection with its plans to install railings on the access steps; conveyed his belief that a portion of the path is located on his property; explained that he does not object to the plan to install railings, but opposes any encroachment onto his land.

Council requested that the City Manager review the survey and communicate with Mr. Abley to ensure that the access does not encroach onto Mr. Abley's property.

# D. Supplemental Funding Appropriation - Fire Station #59

MOTION BY COUNCILMEMBER DAHL, SECOND BY MAYOR PRO TEM EGGLESTON, CARRIED 4-0, to:

- 1. Approve a supplemental appropriation of \$113,000 from the Public Facilities Construction Fund/Public Safety Construction Fee Fund to Account 030-818-45300-000-13002 to pay for outstanding and future change orders related to replacement Fire Station #59.
- 2. Approve, and authorize the City Manager to execute, additional change orders, as needed, in an amount not to exceed the contingency of \$113,000.
- 3. Approve a supplemental appropriation of \$25,995 from the Public Facilities Construction Fund/Public Safety Construction Fee Fund to Account 030-818-45300-000-13002 to provide for additional architectural and engineering services required during the remainder of construction related to replacement Fire Station #59.
- 4. Approve, and authorize the Mayor to execute, Amendment No. 2 to Contract C02-64, by and between the City of San Clemente and RRM Design Group, providing for architectural and engineering services during construction, increasing the cap on total payments by \$25,995, not to exceed a total of \$304,660.47.

# E. <u>Contract Award - Aeration System Replacement and Odor Control Improvements</u>

# G. La Pata/Vista Hermosa Park - Award of Design Services

MOTION BY COUNCILMEMBER DAHL, SECOND BY MAYOR PRO TEM EGGLESTON, CARRIED 4-0, to:

- 1. Approve, and authorize the Mayor to execute, Contract C05-62 by and between the City of San Clemente and David Volz Design (DVD) relating to design services in connection with the La Pata/Vista Hermosa Park, in the amount of \$2,094,442.
- 2. Direct Staff to issue a Notice to Proceed to DVD for intermediate design work, in the amount of \$623,424.
- Direct Staff to bring back to the Parks and Recreation Commission and Council a revised Scope of Work and fee breakdown at the end of the intermediate plans stage.

H. Initiation of General Plan and Specific Plan Amendments - City-Owned Property North of Avenida Vista Hermosa and West of Avenida La Pata

- 1. Approve the street closures for the Marine Monument dedication special event to be held on November 12, 2005 as identified in the Administrative Report, which is on file with the City Clerk's Department.
- 2. Approve the transfer of \$1,000 from Council Contingency Reserve (Account 001-203-44900) to Contract Police Services (Account 001-218-43625) for overtime for Police Services.

## B(2). Zoning Administrator meeting minutes of October 5, 2005.

Council referenced Minor Cultural Heritage Permit 05-093, which is a request to allow façade modifications to an existing residential duplex being converted to a single-family residence at 318 Avenida Del Mar; stated that the Zoning Administrator meeting minutes indicate that the Applicant, shortly before the meeting, requested that a three-car garage be approved instead of a two-car garage; stated that the Zoning Administrator ultimately determined to approve the project with a two-car garage; asserted that the City should allow three car garages in congested areas unless there are overriding reasons to not permit a three-car garage.

#### A. 800 MHz In-Building Ordinance

Report from the Assistant City Manager concerning building regulations relating to public safety radio system coverage.

Purchasing/Budget Officer Elston reviewed the contents of the Administrative Report.

Lt. Hunt and Chief Dave Pierce responded to Council's technical inquiries. During the course of discussion, Building Official Jorgensen stated that the Orange County Communications staff indicated that it would cost a property owner approximately \$10,000 to install an amplification system within an average size four-story wooden apartment building.

MOTION BY COUNCILMEMBER DAHL, SECOND BY MAYOR PROTEM EGGLESTON, CARRIED 4-0, to introduce Ordinance No. 1306 entitled AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN CLEMENTE, CALIFORNIA, AMENDING THE SAN CLEMENTE MUNICIPAL CODE BY ADDING A NEW CHAPTER 8.80, ENTITLED BUILDING REGULATIONS, REGARDING PUBLIC SAFETY RADIO SYSTEM COVERAGE.

Councilmember Dahl reported that the Public Hearing on the Foothill/South Transportation Corridor has been postponed until December 2005 or January 2006.

Mayor Anderson stated that he attended the Economic Forecast this morning that was sponsored by the Orange County Business Council and presented by the School of Business from Cal State Fullerton; advised that the City Manager's Office will circulate copies of the Economic Forecast to Council.
