#### **PART B:** San Clemente Municipal Code Section 3.24.070

- A. <u>Original Delinquency</u>. Any operator who fails to remit any tax imposed by this chapter within the time required shall pay a penalty of ten percent (10%) of the amount of the tax in addition to the amount of the tax.
- B. <u>Continued Delinquency</u>. Any operator who fails to remit any delinquent remittance on or before a period of thirty (30) days following the date on which the remittance first became delinquent shall pay a second delinquency penalty of ten percent (10%) of the amount of the tax in addition to the amount of the tax and the ten percent (10%) penalty first imposed.
- D. <u>Interest</u>. In addition to the penalties imposed, any operator who fails to remit any tax imposed by this chapter shall pay interest at the rate of one and one half (1 ½) percent per month or fraction thereof on the amount of tax, exclusive of penalties, from the date on which the remittance first became delinquent until paid.

- 2. Add applicable penalties and interest if delinquent (See Part B above).
- 3. Make check payable to CITY OF SAN CLEMENTE
- 4. Sign and return this form with payment to the Finance Division. Include all applicable attachments and supporting documents.
- 5. Tax shall be due and payable on or before the last day of the month following the close of each Reporting Period. For example, if the Reporting Period is November 2009, the tax is due no later than December 31, 2009.
- Make a copy for your records prior to submission to the Finance Division.
